AANR Election News

Bev Price Elected Western Region's AANR Trustee

Beverly Price has been elected by AANR voters in the Western Region to serve as their Trustee for the next two years. She defeated Tim Mullins 474-345.



Bev told us: "Thank you, AANR West members, for your vote of confidence. I plan to continue most, if not all, of my efforts in promoting and protecting nude living, as presented in the May issue of the Western Sun. I would like to be on the Government Affairs Team, especially if Tim Mullins expertise continues to be

tapped, I am definitely an advocate of communication, so feel free to contact me at beverly.price@aanr.com with any comments or suggestions.

Other Election Results

The results from the biannual AANR election were announced on Monday June 22. The online turnout was 12%, up slightly from two years ago.

Re-elected to another term as AANR President was Kathy Watzel (Mountain Air Ranch club, Colorado). She defeated former AANR East President Gloria Wayrus by a vote of 2,726 (80%) to 692 (20%)

Candidates for the other AANR offices ran unopposed:

Margie Cantlon (Sun Meadows, Idaho) is the new Vice President

Kathy Smith (Kaniksu Ranch, Washington) was re-elected as Secretary/Treasurer

Also elected were five other Trustees who ran unopposed: AANR-East – Ronna Krozy (Solair Recreation League, Conn)

AANR Florida – BG Parkes (Suwannee Valley, FL)

AANR Midwest – Terry Meek (Forty Acre Club, Missouri)

AANR South West – Ted Peck (Barhide Park, Texas)

AANR Northwest – Karen Lahey (SLUGS, Washington State)

AANR Western Canada – Bob Dixon (Sunny Chinooks Association)

These seven Trustees represent the new look to the AANR Board because in 2018 the membership voted to reduce the total number of Trustees from 14 to seven. There is now one Trustee per AANR region.

All six ballot propositions were approved. These include:

Proposition #1 Won, 97% Yes

This updates the 40-year old AANR mission statement to read as follows:

"AANR exists to protect, promote, provide and preserve nude recreation by:

- Protecting nudists and naturists from policies at the local, state and federal levels that interfere with the right to enjoy clothing-free recreation in appropriate settings.
- Promoting nude recreation by educating government leaders, employers, and the public.
- Providing support services and community to our members.
- Preserving the financial viability, integrity and strength of the AANR organization."

Proposition #2 Failed, 46% Yes to 54% No

Would have brough the AANR rule about family members not serving on the same Board of Directors into compliance with Canada law, since our Canadian clubs were in violation of their national law with our current rules.

Proposition #3 Won, 90% to 10%

This defines the different kinds of AANR memberships (Basic, Associate, Young Adult, Student) and eliminates Couple memberships.

Proposition #4 Narrowly Failed

This eliminates the Student Membership category and folds them into the Young Adult category. The vote was 66% Yes to 34% No, but it needed a 2/3 majority to pass.

Proposition #5 Passed, 77% Yes to 23%

This removed the fixed date for the annual AANR convention each year and makes it more flexible for the Trustees to make a change, if necessary, to avoid scheduling conflicts.

Proposition #6 Passed, 96.5% Yes to 3.5%

This extends the due date of the annual audit of the AANR books from February 15 to May 31, as proponents say the current date is almost impossible to hit every year.

AANR Convention in Texas Changed to Online Meeting

The annual AANR convention scheduled for Star Ranch near Austin Texas from August 11-16, 2020 has been changed to an on-line meeting on Aug 13-14 only, due to COVID-19 concerns.

AANR West Convention News

AANR-West Regional Assembly to Be Both Online and In-Person



Due to COVID-19 concerns we had heard from many of the clubs, the Board of Directors has agreed to change the format for its annual Regional Assembly and Convention so that members and delegates can participate from a distance online if they wish.

Shangri-La is still inviting people to attend in person if they want to come, with face masks and physical distancing precautions being encouraged.

The meeting portion of the convention has been shortened to just Friday and Saturday, July 24-25, with the following morning (July 26) set aside for a meeting of the new Board.

"This is an election meeting with six of the nine Director positions up for grabs, so it is important as many clubs participate as possible," said President Gary Mussell. "The candidate Q&A is Friday afternoon and the election is Saturday mid-morning."



Remembering Doug Triggs August 10, 1946 – May 23, 2020

The members of Mountain Air Ranch are saddened by the loss of Douglas Triggs. He was a loved and respected member for over 40 years.

Doug completed many quality improvements here with not only his physical labor but his financial contributions, although he was very humble and acted anonymously.



His efforts included the playground, the exercise area, the kid's program, and family days among many others. Attracting and retaining families and children was his passion.

His obituary in the local Denver newspaper revealed he had been battling cancer for the past two years.

He was born in Mitchell, South Dakota and attended both the University of Michigan and the University of Denver, receiving his MA degree in International Relations. After service in Vietnam, Triggs settled in Denver as an attorney specializing in bankruptcy law and student loans. But his friends recall his real passion was mountain biking, scuba diving, rope climbing up cliffs.

He leaves his wife of 40 years, Amy, and 3 grown children.

GAT: State Legislation Pending

While a few bills of interest were introduced this year, they never got out of committee because the legislatures recessed prematurely this spring due to the COVID-19 pandemic, the nudist community has had an easy time of it this election year.

Wyoming HB 48 - This "voyeur" bill makes it a felony to use any device to take "intimate" photos of another person without their consent. The bill is cosponsored by 10 House and 2 Senators. We are concerned because voyeur bills seem to be magnets for amendments that often target public nudity. We also must be careful about "penalty creep" when a certain offense goes from one felony level to a worse felony level, for example, just to make the legislator sound stronger on crime. Status: On Hold by the House Judiciary Committee. No Hearing Date Set.

Arizona HB 2703 - This proposed law allows a civil penalty after an alleged invasion of privacy caused by any unauthorized capture and dissemination of "a live visual image, sound or other physical impression..." Existing Arizona law already addresses civil remedies for theft of property. Status: Held (postponed) by the House Judiciary Committee. No Hearing Date Set

California SB 798 - The intent of this bill is to make it illegal to send photos to anyone through a phone without their consent. It's a civil bill not criminal. The author says it is to be modeled after a similar Texas law, however at this point the bill is just a shell with no details, making it ripe for lots of amendments that may or may not be of interest to nudists. Status: Held (postponed) by the Senate Judiciary Committee. No Hearing Date Set

California AB 2065- Existing law makes the sharing of intimate images of another person, as specified, that were intended to remain private, and that result in the serious emotional distress of the person depicted, a misdemeanor. This bill would make the offense a felony and require the offender to register as a sex offender. The offense does not rely on the intent of the alleged perpetrator, instead, it's based on the perception of the action by the alleged victim. This proposed new law does not exclude artwork nor exclude photos in a place (such as a beach) for which there could be no reasonable expectation of privacy. Women's breasts are excluded from the definition of "intimate body parts." This is a vaguely written bill that no doubt will bring grief to nudists who innocently take phots of each other. Status: A hearing on the bill March 17 was postponed due to the COVID-19 legislative recess.

Beaches, Lakes, and Hot Springs

Auburn Dam (Sacramento River)

June 26 – After three years of public hearings, a semi-final draft of the Auburn State Recreation Area General Plan was released for public review. It is about 500 pages long and covers in detail the California State Park Department's plans for the area over the next 20 years. Local nudists from the Northern Exposure and River Dipper clubs have enjoyed a traditional clothing-optional beach just below the Auburn Dam, yet we have been unable to get official recognition despite years of trying. The dam is located above Folsom Lake northeast of Sacramento, California.

Members of these clubs attended several of the public hearings about this Plan update to protect our interests, and many letters were written asking for proper signage.

To our frustration, the final draft mentions nothing about the nude beach. We don't know was deliberate, as in live-and-let-live, or an oversight.

The public can further comment until September 17. A final Plan is scheduled to be voted on by Month, 2021.



Deep Creek Hot Springs (San Bernardino County, CA)

Last month, we discovered a new fence was placed across the road to the traditional parking lot that takes visitors to this popular clothing-optional hot springs in the San Bernardino Mountains above Apple Valley.

We learned a land survey 80 years ago was incorrect and the western half of Bowen Ranch did not actually belong to the Ranch. Someone discovered the error and recently bought the parking lot that provides access to the trail to the Deep Creek Hot Springs.

That road is now closed. We don't know the new owner's attitude toward allowing nude hikers to use the trail once the property reopens.

Meanwhile, the Bowen Ranch owner has created a new road that parallels the new fence. Those who have used it reported they found this route to be longer and a little rougher going, but useable.

Lake Tahoe (Nevada Side)

The local club reports the beaches around the lake have seen an unusually high number of beach attendees this spring. The Tahoe Transportation District is working on a unified parking management strategy for the Lake Tahoe region. The Tahoe Area Nudists later contacted the agencies involved to voice their concerns about increased public access to their secluded beaches.

The club reports the non-nudists are leaving lots of trash along the trails and the highway as the authorized trash cans full and not being collected due to the shutdown. The Tahoe club is making plans for several cleanup events during June and July along the highways and trails near their beach area. It is hopeful these activities will provide some positive public relations for the club.

Florida Gains A Second Legal Nude Beach

June 20, 2020 – St. Lucie County Commissioners have voted to officially designate the half-mile of beach as a legal "Naturist Beach." The vote was 4 to 1.

The commission and other county officials also commented on how the naturist beach visitors kept the beach clean by taking out food and drink containers, educating new visitors on keeping out of the delicate dunes, and because of the beaches remote area, the Treasurer Coast Naturist association leased portable restroom facilities for the beach visitors use.

Previously, the St. Lucie County Tourist Development Agency also voted unanimously to support the designation. Blind Creek Beach is the second officially designated naturist beach in Florida, but the first one designated by a county ordinance. Haulover Beach Park's designated Naturist Beach to the south in Miami-Dade County was designated in 1991.

The St. Lucie County Park Department will soon be installing **signage** alerting visitors to Blind Creek Beach of its clothing-optional status.

When asked about potential user conflicts, one county official commented: "If the nudity offends you, you can solve the issue by averting your eyes."

It was further pointed out by a government official that "Florida has over 860 miles of sandy beaches, Certainly, a few miles dedicated here and there for naturist beaches won't deny anyone of a beach to visit."

More Community Events and Trade Shows Cancelled Due to COVID-19

Sadly, some additional events scheduled for the summer months have been cancelled due to social distancing concerns.

Carpinteria's Avocado Festival/Independence Day Parade

Organizers of the annual Avocado Festival have decided to make the scheduled October 2-4 event a "virtual" one. We have staffed an information booth there for the past 3 years. The Festival normally draws 100,000 visitors over its 3 days and brings in over \$2 million to the beach town's economy.

San Diego Earth Fair

This is largest Earth Day celebration in California and easily draws 100,000 people to its 400 booths. AANR-West and the local club share a booth promoting nude recreation and always draws a receptive crowd. The Fair, usually held in April, was postponed until mid-September, but lingering COVID-19 concerns have caused the organizers to cancel for this year.

National Conference of State Legislators

The annual National Conference of State Legislators (NCSL) meeting scheduled for August 22 - 28 outside Denver, Colorado has been officially cancelled

AANR has had a booth at this meeting for about two decades and we use it to make contacts with key legislators affecting nude recreation across the 50 states.
