AANR-West Board Meeting Moved to De Anza Springs for Nov 14

The AANR-West Board Fall Board meeting will be held Saturday, November 14 at the De Anza Springs Resort in Jacumba, California.

The Fall meeting is when the Board creates and approves its budget for the following calendar year. The 2021 budget will be particularly scrutinized as we do not yet know the impact of COVID-19 on our membership numbers or what activities we can plan.

The meeting will open at 9 am and last until about 5:30 pm as the nine Board members and four officers deliberate on the best ways to carry out our mission. Such topics as what trade shows to attend, launching a new Passport program, establishing inter-club sports competitions, and finding alternative sources of revenue will all be on the table.

Also to be discussed is the final design for the new AANR-West GPS T-shirt, to be sold by the region starting next year and also through the 2021 Passport books. More about this in the December newsletter

We originally announced the meeting would be at the Glen Eden Sun Club near Corona, but a sudden increase in COVID-19 cases in that club's county caused restrictions on meetings to be re-imposed (see Club News elsewhere in this newsletter). The region quickly moved the meeting to a different county with a lower COVID-19 infection rate, about two hour's drive to the south. We hope to return to Glen Eden in the future once the virus regulations allow.

At the new location we are allowed to meet in person, with mask and social distancing protocols in force. De Anza graciously stepped up on short notice and we appreciate their hospitality.

AANR members are invited to attend (either in person or by video link) and advocate for specific programs and policies if they wish.

Reminder: Co-Op Advertising Receipts Deadline is November 30

AANR Western Region chartered clubs may be reimbursed for advertising in outside (non-nudist) publications or online sites. To qualify for reimbursement:

- (a) the advertising must specifically have a link to the AANR-West website home page (www.aanrwest.org) and
- (b) the logos of AANR, or AANR-West (or both) should be displayed if space permits, and
- (c) the club's website home page must provide a link to the AANR or AANR Western Region website page.

(d) Copies of 2020 club receipts or bills which have been paid, and a copy of the advertising must be submitted to the AANR-West Treasurer no later than Nov 30.

(e) Ads in AANR's *The Bulletin* and other AANR publications are not eligible for reimbursement. Advertising in any other nudist publication must have **prior** approval of the AANR-West President for reimbursement.

Clubs can be reimbursed at either **50% of the cost** of qualified advertising, the amount not to exceed **\$400** per year per club, or at 25% of the cost of qualified advertising, the amount not to exceed \$1,000.00 per year per club, at the club's option.

A bonus for 100% membership clubs: Reimbursement can be as much as 50% of the cost of qualified advertising, the amount not to exceed \$800 per year per club, or 25% of the cost of qualified advertising, the amount not to exceed \$2,000 per year per club, at the club's option.

Advertising which conflicts with the principles and standards of AANR and/or AANR-West is not be eligible for reimbursement.

Provisional (newly formed) clubs are not yet eligible for co-op advertising reimbursement.

AANR International has a similar program with similar guidelines. By submitting to both, a club could "double dip" and possibly get a rebate for nearly 100% of their cost. Advertising does not need to be in the print media. If a club bought coffee cups with the AANR or AANR-West logo, for example, they could be eligible for reimbursement up to a certain dollar amount.

Olive Dell Hosts Annual "Naked Beer Mile" Run

Probable a more accurate title to this article would be: The Alcoholics Who DON'T Remain Anonymous Beer Run.

Olive Dell Ranch's Naked Beer Mile traditionally is run on Saturday, before the grueling Bare Burro 5K. Due to COVID-19, these events were postponed until the weekend of October 24-25.

This year we had about 40 people participate in the Beer Mile, which was smaller than last year but considering the virus restrictions, still a pretty good turnout. The weather at the time of the race was in the mid-60's, so drinking a cold beer was not as refreshing in previous years, but those of who signed up did so because it remains one of the most stupidly fun races you can ever do, regardless of the weather. It starts out really competitive, yet by the time we all cross the finish line, nobody really cares who won.

Before the start, everyone must raise their right hand to take a verbal oath, which went something like this:

- 1. I will drink more than I think I can
- 2. I will be drunker than I think I am
- 3. I will not barf

The race is a quite simple concept. It's held on a 1/8 mile stretch on one of the roads at ODR. You start your run uphill at the top when you give the manager, Becki Kilborn, a high five. You then turn around and run back down the hill and drink a full can of beer back at the start. For those who don't want a beer, there are sodas, but in reality, this is a worse choice because of all the carbonation!

So, the run sequence goes like this: Drink a beer as fast as you can, hold the empty over your head, and run 1/4 mile. Repeat three more times (if you can).

Along the sides of the course there are many people who applauded the runners. Their cheers inspired us on when things started to get a little fuzzy in the brain. I noticed Brian, one of the new owners of ODR, was cheering us on from the patio.

I also noticed as the race went on, that several of the runners got creative with the rules. I saw one person shake their beer can first before opening, causing lots of beer to "accidentally" shoot out for the can, thus leaving a little less for them to guzzle. I saw others letting the beer run down their chin onto the ground, essentially with the same result as the first guy. Later, one other said, "Oh I have to pee" and spilled some of his beer near his crotch area. Me... well, I drank half of my beer and handed it to someone and said, "hey, hold my beer and watch this", and I went and ran.

The beauty of the Beer Mile is people really do forget what lap they are on. Some people ran only 3 laps, some 4 laps (a full mile) and a few guys ran 5 laps because they lost count. I suspect a few might still be running if we had not stopped them.

But once the finish line is crossed, there is an amazing participant medal for you: it's a recycled beach shovel.

Patrick, one of the race organizers, runs along Manhattan Beach often. While running, he picks up the discarded beach shovels left on the sand. He repurposes these into our winner medallions. I cannot express how much meaning these have to us. Patrick has picked up someone else's trash and turned it into gold for us. And just to show off, a few runners wore their past "medals" during the race as badges of honor!

If you have never done a Beer Mile, this is the best way to do it, nude and breaking all the rules along the way. Trust me, you won't get banned from next year's run.

Olive Dell's Annual Bare Burro 5K Run Is Great Fun!

Thanks to the COVID-19 crisis, Olive Dell's 11th annual Bare Burro 5K race was delayed from their traditional date in April to Sunday, October 25th. I arrived at the gate a few moments before it opened at 8 am and drove right up to my surprise. There were only a couple of cars parked on the side instead of a huge line as there have been in years past.

We got a table on the patio and settled in with a hot cup of coffee for one of the premier naturist events in Southern California. While it was overcast and only in the low 70's it was really perfect weather for running a 5K.

As in the last couple of years, I didn't walk, or run in the race, but attended to represent the SCNA, greet members, answer questions about the club, and catch up with old friends from Olive Dell and other groups. I got to meet one of our newest members in person, Zachary, and present him with his new membership card!

Whether it was due to COVID-19, or the cooler weather, only around 120 people showed up to participate in the race. This was down from over 300 last year. In order to safely distance everyone, the runners were grouped into small groups of 5 that were set off on the course at timed intervals starting at 10:30 am. Also, the starting gate was reversed this year, so the runners had to start running uphill right away. Most of the runners will tell you that it's a challenging course.

The fastest runners started arriving back in just over 20 minutes with the rest of the runners and walkers coming in over the next 90 minutes. Around 12:30 the awards ceremony started with the top three contenders in every age group receiving a nice medal and some Gooder® sunglasses.

Congratulations to AANR-West board member Claudia Kellersch and her son Alexander (second photo at right) who both medaled in their age divisions.

About 10 minutes into the ceremony an intermittent drizzle began coming down on us. Some of the runners said it felt good after their race. The drizzle only lasted about 20 minutes and by mid-afternoon the sun finally broke through.

We highly recommend this event, whether you want to run, walk, or just come out, and enjoy the afternoon naturally!

Olive Dell is planning on hosting the 2021 race back at its usual date and time in late April. Note: The Boston Marathon, originally scheduled for April, will be postponed until at least autumn, 2021, so all serious runners have no schedule conflict should they wish to fulfill their bucket list item and run in the Bare Burro event!

Government Affairs



How the Results of the November Election Affects Nudists

After all the angst and tension leading up to the November 3 general election, it seems the voters have decided that they prefer the existing status quo, at least at the Congressional and state legislative levels. Here are two reports:

National Policy

First, I don't anticipate anything happening legislatively to directly affect social nudism. It is likely that Congress would continue to defer to the states on such matters.

Second, there could be changes by any of the land managing agencies to the Code of Federal Regulations. For example, the National Park Service could ban nudity across the board, instead of just at certain units, such as Cape Cod. However, I don't see that as probable. More likely would be regulatory changes at specific parks. And I see that happening only where park staff resources are not adequate to control crowds in places where numbers of users have increased dramatically because of opportunities to be nude (as at Gunnison Beach at Gateway NRA and at Fire Island). It could happen also where textile users have complained about proximity to nude users and the nudists haven't made a strong enough case for their rights. That kind of situation in the NPS is usually dealt with by banning nudity though a new Superintendent's Compendium that does not have to be publicly reviewed like regulatory changes do. I imagine similar arrangements would be made by the other agencies.

Third, I believe that the most likely losses of nude recreational opportunities would come as a result of cutbacks to staffing and maintenance by the land managing agencies due to insufficient funding. When an agency doesn't have enough money, it typically will tighten its belt by restricting access to certain places where they can't maintain ranger patrols or by discontinuing maintenance of roads, trails, campgrounds, and other amenities with the result that people no longer are attracted to those places.

While restrictions such as these can be handled by a Superintendent's Compendium initially, if enough units face the same situation, we likely will see agency-wide regulations put in place. Similarly, we could even see some units closed entirely or turned over to state operation.

My opinion is a Biden administration would try to maintain recreational funding and restore environmental protections that Trump has cut, but this could be hamstrung by insufficient Congressional funding.

State by State Results

Arizona

This state narrowly went for President-elect Joe Biden over President Donald Trump by about 60,000 votes (unofficial).

Former astronaut and gun-control activist Mark Kelly defeated incumbent U.S. Senator. Martha McSally (R) by 53% to 47%. This is the first time since 1953 that the state has been represented by two Democrat senators.

The state's nine U.S. House seats remain split between five Democrats and four Republicans.

In the legislature, Arizona remains a Republican "trifecta" at the state level. Democrats thought they had a chance at winning a majority in the state House, but they fell short by 3 seats. Bottom line is no change in policy is expected for nudists.

Last, Arizona voters decided by a wide margin to legalize possession and recreational use of marijuana.

California

This state remains the "bluest" of the "blue" states, with Democrats holding all statewide elected offices, and holding a 2/3 majority in both the State Assembly and State Senate. The California Senate will go from a 29-11 Democratic majority before the election to a 32-8 majority following the election as three Republican incumbents lost their races. By comparison, no incumbents in the Assembly lost their race on election night. The first openly bisexual, 25-year-old Alex Lee was elected to the Assembly.

New bills can be introduced starting December 1.

Fifty-three members of Congress come from California. Each party flipped one seat with three still too close to call. The current count is 40 Democrats, 13 Republicans.

There was no election this year for U.S. Senator from the state. However, with the election of **Kamala Harris** to the Vice Presidency, Governor Gavin Newsome gets to appoint her successor (who will need to run again in 2022).

California Beaches Towns

Carpinteria

Our favored candidates won their seats on the Carpinteria City Council in last Tuesday's election. As expected, Mayor Wade Nomura was re-elected in a landslide and Natalia Alarcon won the open seat vacated by our friend Council member Fred Shaw. McIntire, who opposed our beach, came in a distant third.

Pirates Cove, San Luis Obispo

Farther north in Pismo Beach, we had mixed results. Scott Newton, a friend of nearby Pirate's Cove nude beach came in first place for city council, but incumbent Erik Howell, another friend of the beach placed third and lost his seat since only the top two won. Howell is also on the CA

Coastal Commission and has been a staunch champion of the beach, but his loss also means he loses that appointment.

The Governor gets to appoint Howell's replacement and so we are lobbying for him to appoint Newton. We will not know his choice for a few more weeks.

Colorado

Ex-Gov. John Hickenlooper (D) won the Colorado U.S. Senate seat currently held by Sen. Cory Gardner (R) by a 55% - 45% margin.

Democrats also picked up a Congressional seat making that count now four Dems and three Republicans, with one not yet decided. Congressman Jared Polis will be the country's first openly gay man to serve as governor.

Colorado's State Senate also flipped with 18 Dems and 17 Republicans, while the state House now has a Democratic majority 37-23, a net gain of four for the Democrats.

Coloradans also approved the state joining the National Popular Vote Interstate Compact.

Hawaii

Hawaii has been a Democratic trifecta for many years, controlling all state elected offices, and both state houses by wide margins. The party won the single US Congressional seat by a 50% vote margin. Of the seven seats up for election in the State Senate, Democrats won 6 and Republicans won 1. In the State House of Representatives, Democrats won 27 and Republicans won 3.

Biden won the state's 4 presidential electors, 64% to 34%. Hawaii has not supported a Republican candidate for president since 1984.

Nevada

Biden remains ahead of Trump in the presidential election by nearly 3%, although some are asking for a recount. No Republican presidential candidate has carried Nevada since 2004.

Two incumbent U.S. House members, Republican Mark Amodei in northern Nevada and Democrat Dina Titus in Las Vegas won reelection Tuesday. The other House race is still too early to call. Democrats continue to control both houses of the state legislature by wide margins.

Nevada voters overwhelmingly agreed to make the state the first in the nation to protect same-sex marriage in its constitution.





The AANR-West region covers eight states and western Mexico. This map shows how the Western Region voted for president, November 2020 (Blue = Biden, Red = Trump).

New Mexico

Biden won the state 54%-43%. Democrats expanded their domination of the state's legislature. State Senate: 26 Dems to 15 GOP, State House: 42 Dems and 25 GOP. Women are expected to hold a majority of seats in the state House for the first time. New Mexico elected its first Black senator. Harold Pope Jr., a Democrat, defeated a three-term incumbent to win Albuquerque's District 23. Three Senate races and five House races remain undecided

Democrat Ben Ray Luján won the open U.S. Senate seat. His victory ends a 44-year hiatus from Hispanic leadership in New Mexico's U.S. Senate delegation. The last was Democratic Sen. Joseph Montoya, who lost reelection in 1976.

Utah

Utah remains a Republican trifecta, controlling the governorship as well as a large majority in both the State Senate and State House although the Democrats had a net gain of four seats in the lower house. Gov. Gary Herbert (R) did not run for re-election this year. Spencer Cox (R) defeated Chris Peterson (D) by 61% to 34%. This is the 11th consecutive gubernatorial election Utah Republicans have won, the longest current winning streak nationwide. Utah Republicans have controlled both U.S. Senate seats since 1947.

Wyoming

President Trump won 70% of the vote in this state. Republican Cynthia Lummis also won the open U.S. Senate seat with 73% of the vote. The state's sole member of Congress, Liz Cheney, daughter of the former U.S. Vice President, won with 68% of the vote.

Wyoming is also a Republican trifecta, with that party holding the governorship and a wide majority in both the legislative branches. Republican state representative Roy Edwards (R) died a day before the election but he won anyway.



ARIZONA

Movie Review

SKIN: A History of Nudity in the Movies

Did you know the first movie to win a best picture Oscar (the 1927 silent film "Wings") had both male AND female nudity? This and other fascinating facts are on display in this fascinating and definitive documentary on the history of nudity in the movies.

Director Danny Wolf traces nudity in Hollywood films since the late 1800s, beginning with the silent movie era through present day. By doing so, he also examines the changes in morality that led to the Motion Picture Production Code in 1934, which set moral guidelines for what's acceptable or unacceptable in the film industry. Wolf guides us through the puritanical hurdles of these rules, also called the "Hays Code," and the games of double entendre and innuendo played by script writers and the studios to get around it. Examples: can Jane Russell carefully bare cleavage to get by the censors? Are DeMille's Biblical epics okay for public consumption if the nudity is in the service of factually depicting Roman orgies?

To its credit, Wolf does not dwell on "great moments in nudity" but rather peppers his history with several dozen actors and directors whose performances marked the changes in what was accepted by an ever-changing public over time.

In 1968, the Code was replaced by the MPAA and its G, PG, PG-13, R, and NC-17 (originally "X") film ratings that we know presently.

Among the talking heads here are a who's who in Hollywood, including Peter Bogdanovich, Shannon Elizabeth, Pam Grier, Mariel Hemingway, Traci Lords, Malcolm McDowell, Eric Roberts, Kevin Smith, and Sean Young, among many more.

Also discussed are the contributions of actresses like Marilyn Monroe, Jayne Mansfield and Mamie Van Doren, "who knew way back when that sex sells."

I found particularly enlightening the comments by Malcolm McDowell on how *Caligula* was hijacked from a serious film and turned into soft porn. Director Amy Heckerling explained how *Fast Times at Ridgemont High* avoided an X rating by having the studio, over her objections, edit out the male frontal nudity in the essential sex scene between teens Jennifer Jason Leigh (her frontal nudity was okay) and Robert Romanus.

Shannon Elizabeth chats in the "Skin" documentary about her breakthrough role in *American Pie* whose foreign-exchange student Nadia disrobes to just her panties. The movie "changed everything," she says. "If I hadn't done the nudity, I might not have a career today."

The film also digs into the impact of the #MeToo movement that is challenging the power of present-day entertainment industry practices. It singles out the discredited Harvey Weinstein and also others who have been accused of improper and/or illegal behavior.

It culminates with a look at CGI nudity that seems a large part of motion pictures' future. The documentary will compare the use of nudity to further storylines vs. simple exploitation and discuss how nudity is used in movies today with the explosion of must-see television (*Game of Thrones, Shameless*) and its influence on the film medium. It also informs that actors and actresses now typically have very detailed contractual protection in regard to nudity.

The documentary runs a very fast 2 hours 10 minutes in length. It is available through Vudu, iTunes, and other Video on Demand platforms like Fandango Now and Google Play. On Prime Video, one can rent it for \$3.99.
