The water volleyball tournament had teams representing SLR, Mira Vista, Glen Eden, and DeAnza; with Glen Eden taking home the Fall Festival Championship title. Winners were awarded AANR-West cool neck sports towels. Music around the pool was provided by Broadway Joe and Anita for a great afternoon.

The clubhouse was transformed into a Hawaiian escape for Saturday night. An authentic dance group came in and did an amazing performance that had everyone mesmerized. AANR West Vice President, Cyndi Faber and Jeff Tendick, AANR West director even learned a few new dance moves. After the performance Joe and Anita continued the celebration into the night with great music for everyone to dancing enjoyment.

A good time was had by all and we can't wait until we have another opportunity to get together again here or at another great AANR-West club.

DE ANZA SPRINGS BARE BOOTY 5K: MY FIRST TIME RUNNING NUDE!

This was the inspiration behind the Bare Booty 5k run held at DeAnza Springs Resort. This time I stood behind the table handing out, rather than collecting, the pre-race T-Shirt. This time I stood with a stopwatch to the side of the finish line, rather than running across it. This was my first experience organizing a 5k run.

DeAnza Springs Resort borders the Anza Borrego Desert State Park. Trails run along the ridges to the North of the resort, exposing hikers to the wilderness. I knew these trails would form the great basis for a 5k run. September weather is predictable in this region, with near certain blue skies, and temperatures in the 70s at the race start time.

As this was some runners' first nude activity, I did not want them to be cold, and wish they had hung on to their clothes.

A team of volunteers, mainly residents of De Anza Springs Resort, worked so well together on the day.

For all of us this was our first event, so inevitably there was some learning as we went, but overall things went well. No one took a wrong turn, no one was injured, and no one was lost in the desert.

In all 63 participants registered for the run. Ultimately it was the spirit of the runners impressed me most. Some were nudists out to experience a 5k run, and some were runners trying a nudist activity for the first time. For one brave sole it was both. She arrived clothed to cheer for her boyfriend and ended becoming a participant in the nude run. She had a great time. Stepping out of your comfort zone leads to new experiences. Based on feedback these experiences were very much positive.

The runners made this experience a success. I would like to thank all who took part. Before the run I was unsure whether I would repeat this effort, but because of the response I will organize an event run again next year (Sunday, Sept 22, 2019). See you all there!


Meanwhile, Glen Eden went ahead with plans for an Old Timers Reunion bash on October 12-14 for those who have been GE members for 20 years or more.

BURT REYNOLDS PHOTO PUTS AANR-WEST INTO “FACEBOOK JAIL”

AANR-West acknowledged the death of actor Burt Reynolds on September 6 by posting his iconic centerfold from the April 1972 issue of *Cosmopolitan Magazine*. The response from both Facebook and Twitter were immediate: “the post goes against our standards on nudity or sexual activity” wrote Facebook as it took down the AANR-West FB site for 30 days. Twitter did the same a few hours later. Andy Walden, our Social Media coordinator got Twitter to reconsider a few days later, but Facebook took a few days more to apologize and to restore nearly 100 web sites, including ours, who had been put into “Facebook Jail” because of the photo.



ORIENT BEACH MANAGER DECIDES TO CLOSE RESORT

Stephen Payne, Director of Club Orient on St Martin island in the Caribbean, has sent to letters to its customers stating that because of a continued delay in receiving funding so the resort can be rebuilt, the management company (OBC), who employs the staff and operates the resort, must close its operation. Even if the money is received by next month (November), the place could not reopen until next summer at the earliest. “We just don’t have the money to keep paying staff and other expenses until then.”

“OBC expects to be legally closing its doors over the next thirty days with the assistance of a government liquidator.”

The letter ended on a hopeful note: “This does this mean Club Orient is finished...It merely means the management company OBC...is closing.”

Once the [land owner] receives its funds and the re-building commences, a new management company would have to emerge to operate Club Orient.”

“So, this is a very sad time for all of us...Our website and Facebook page will remain up for at least the next few months...Thanks to all of you for your support over the years...Au Revoir.”

UTAH ORDERED TO PAY UP AFTER LOSING 'DEADPOOL' THEATER CASE

Lawmakers and the governor in the conservative, predominantly Mormon state had backed a law that is largely aimed at strip clubs but also prohibited serving booze during films with simulated sex or full-frontal nudity.

Until now.

A movie theater sued in 2016 after Utah regulators threatened to fine it up to \$25,000. The state defended the measure in court, calling liquor and sex an “explosive combination”

In September, after a lengthy trial, a Federal judge struck down the law last year as a violation of First Amendment rights, ruling the theater is not an adult-oriented establishment and *Deadpool* is a mainstream, R-rated movie. The judge ordered the state to pay more than \$475,000 in legal fees after it lost a court fight over a law that banned serving alcohol during the racy, foul-mouthed superhero film *Deadpool*.

Liquor authorities were concerned about a suggestive scene in the film's credits involving a cartoon unicorn, among other things. The theater's attorney and former Salt Lake City Mayor Rocky Anderson argued that the law was so vague it would apply to Michelangelo's "David."

His office was awarded attorneys' fees and an additional \$3,800 in other legal costs. *Deadpool* star Ryan Reynolds held a fundraiser that raised \$22,000 for the plaintiffs and this was deducted from the final financial award.

Idaho lawmakers repealed a similar law last year when a theater sued after its liquor license was threatened for showing *Fifty Shades of Grey* while serving alcohol.

SEXUAL HARASSMENT LAW STRENGTHENED IN CA

IMPORTANT NOTICE FOR ALL LANDED CLUBS IN CALIFORNIA WITH 5 OR MORE EMPLOYEES:

Currently, the relevant provisions of California’s Fair Employment and Housing Act (“FEHA”), sections 12950 and 12950.1 of the California Government Code, require employers with 50 or more employees to provide sexual harassment training for all supervisory employees.

SB 1343 amended these provisions, instead requiring employers of five or more employees—including **seasonal and temporary employees**—to provide sexual harassment training for both supervisory and non-supervisory employees by January 1, 2020.
