

AANR-West Kids' Camp Is Cancelled for June 21-25

Sadly, this year's extraordinary pandemic conditions have made it impossible to carry out a successful youth camp June 21-25 at De Anza Springs. We have had no choice but to cancel the event.

Because of current state restrictions, De Anza could not provide a dorm-style sleeping area, and no self-serve buffet style food service was available (a necessity for summer camp dining), and the park is unable to cater to the special dietary needs of some of the kids. Also, while the indoor and outdoor pools have reopened, social distancing requirements meant we could not do any of the water sports we had planned.

As part of the activities, we had planned a field trip to Black's Beach, San Diego's local naturist beach. While the beach is open, face coverings must be worn on the beach and group activities are not yet permitted.

We hope to have all these fun activities available for our 2021 summer camp! I hope the three girls and three boys who had signed up will look forward to next year with me.

I wish to thank my team of local and out-of-region experienced counsellors and director for keeping themselves available. Naturist Society's 2020 Western Gathering Is Also Cancelled

The Naturist Society has announced they are "reluctantly" cancelling both the Eastern and Western Naturist Gatherings for 2020. The Western Gathering had been scheduled for Thursday – Sunday, June 18 – 21 at De Anza Springs Resort, during the few days just before the AANR-West Kids Camp at the same park (now, also cancelled).

World Naked Bike Rides Cancelled in Portland and Los Angeles

Organizers of the **Portland World Naked Bike Ride** posted a similar message on their website although they are also expressing the hope that some riders may choose to do the ride themselves after dark on June 27.

Portland's is the largest Naked Bike Ride event in the world with an average of 10,000 riders each year.

Meanwhile, the statement below was issued by the WNBR-LA Board of Directors who organize the ride:

"We have been carefully monitoring California's modified stay at home orders as well as both LA city and county updated health regulations.


"We also have been collecting feedback from our volunteers and many former riders on Facebook, several have expressed that even if we held a ride this year they would not attend.

"While the ride is a protest and we could choose to exercise our First Amendment rights, doing so under the current circumstances could be detrimental to both our health and to our ideals.

"Therefore, we regret to inform our riders that we have decided to cancel the WNBR-LA this year."

"We hope to come back in the summer of 2021 with an even better ride! We look forward to seeing you then!

Remembering David Cheek September 1, 1943 – May 3, 2020

Last month we lost David Cheek, age 77, a popular former President of the Western Sunbathing Association (the previous name of AANR-West).

Cheek died from a chronic heart condition after a long illness. He had retired to Olive Dell Ranch (ODR) and been an member there for over 30 years.

Becki Kilborn of ODR emailed us: "David loved playing Texas Hold'em and he was one of the smartest guys I knew. He was a member of Mensa and loved watching *Jeopardy*. Not to mention he was a hell of a nice guy, who I considered a very dear friend. We all miss him."

Cheek served as WSA President from 1980 thru 1983. He then was the organization's Secretary/Treasurer from 1984 thru 1989. He was also a member of its Board of Directors for several years and

David was also technically savvy and helped create the region's first web site.

Also, he was the first editor and publisher of *The Western Sun*, the region's newsletter. At his death he still maintained an active Twitter website.

He served the organization for over 40 years.

His tenure in office was a period of transition for WSA into AANR-West as it changed from overseeing a group of smaller nudist camps into interlocking destination parks.

David was always seen to be a gentleman, an avid reader and historian, and a loyal friend to those who knew him. His wry wit was always appreciated, and he would insert humor at the appropriate time when needed during heated discussion.

Clubs get delegates based on a formula of one vote per 25 AANR members.



AANR International Elections: Remember to Vote by June 20

As we reported last month, the online and mail-in balloting period has opened for all AANR members to vote in the biennial elections. **The deadline for voting is June 20.**

While many of the positions at the national level are uncontested, members in the Western Region have an important decision to make regarding the AANR Trustee Board:

Tim Mullins, chairman of the AANR Government Affairs Committee, is seeking the Trustee position to represent the Western Region.

He is opposed by longtime Trustee **Beverly Price**.

Members of the Western Region also get to decide if incumbent **Kathy Watzel** gets a second term as AANR President. Her opponent is **Gloria Wayrus** who is a former president of AANR-Eastern region.

The May AANR *Bulletin* magazine and our own May issue of *Western Sun* newsletter contained summaries from all the candidates, their campaign statements, as well as a review of the six ballot propositions that modify some of the language in our ruling By-Laws.

At least one additional reminder will be sent by AANR to all who have emails within the next two weeks. Please remind your club members to vote so that they may help determine the future of their association.

AANR International Convention

The annual AANR convention remains scheduled for Star Ranch outside Austin Texas from August 11-16, 2020. Kathy Watzel, AANR President, said the main office is watching the COVID-19 infection rate carefully but with proper social distancing the organization feels the meeting can go on safely. The problem now is that the Canadian border remains closed so our members (and the AANR-East President) from north of the border are not able to attend until the border opens again. A final “go/no-go” deadline is June 15.

ARIZONA

- **Mira Vista**

June 1: We are now accepting day guests and new visitors. We will do our best to provide a clean and safe place for you to relax and enjoy while visiting Mira Vista. There will be hand sanitizer in all the common areas. The lounge chairs, common areas and public bathrooms will be sanitized daily.

The main pool and volleyball pool will be open but no volleyball at this time. The Conversation pool and Jacuzzi will be remained closed.

The Cantina in the main building will be open for cocktails to go. Restaurant and Lounge are currently closed. Please continue to practice social distancing of at least 6 feet apart. The pool lounges are spaced accordingly.

- **Shangri-La (New River)**


“We have postponed the annual **Comedy Show** until July 11. The park has postponed its **Bare Burro 5K Trail Run**. until October 25.

- **Wasatch Naturists (Salt Lake City)**


