President's Report

I have had a very busy Fall and Winter since our last Board meeting. Here is a summary:

1. Glen Eden

As the Board knows, both in December and again in January, the Glen Eden Sun Club experienced major flooding, mud, and debris flows following a series of heavy rains that dropped several inches of rain within a few hours on the area. Flooding closed most major streets for several days each time along the I-15 Freeway between Corona and Lake Elsinore.

Although the park did not suffer major damage, many of the streets and two of the six tennis courts were out of commission for several days after each storm. No one was injured and none of the core area buildings, the library, or the pool area were damaged at all. The January storm destroyed the Connett Bridge over Indian Creek, but a temporary span was built a few days later.

As of this writing, GE is evacuated again as a third group of storms hit California.

We have made the park management aware of the Glen Miller Fund in case they want to take a loan from AANR-West to help with their rebuilding but so far they have declined the offer.

2. Legal Affairs

In December, our legal counsel Greg Wilkinson told me he has recently taken a full-time job with a corporation as their legal counsel. We discussed the dissolution of Greg's contract with AANR-West. He agreed to complete the list of outstanding legal issues we had without fee. A list of those outstanding issues may be found elsewhere in this packet.

Meanwhile, Greg recommended we contact the local bar association for referrals for a new attorney, which I have started to do. Thank you, Greg, for your service these past 18 months. We look forward to a positive conclusion to our contract in the next few weeks.

3. Ernie

A week after our November Board meeting, I received a phone call and email from Bev Price, who said AANR-West Director Ernie Wiese was not an AANR member and therefore he had to be removed from our board and the actions taken at all meetings where his presence made the legal quorum were invalid. This meant we could have no 2019 budget since we only had the bare minimum in attendance at the November meeting to pass the budget.

I contacted Ernie, and Mountain Air Ranch, and the AANR office (several times), AANR's Executive Director, AANR President Kathy Watzel, and our own attorney Greg Wilkinson. I sought the facts of the matter, their counsel and advice.

The truth seems to be that Ernie was an Associate member when he joined Mountain Air Ranch, which is a 100% club. Ernie thought the club would take his AANR membership out of his dues there, and the club thought Ernie would continue to pay his AANR membership directly. This went on for three years and Ernie did not wonder why he did not receive his AANR renewal card. He casually mentioned it at the November Board meeting, and this is what launched the whole investigation.

Following my phone call to him, Ernie immediately paid his AANR dues and he also paid his back dues to Mountain Air, which forwarded the money to AANR. Ernie now has his card.

Our attorney researched the legality of it all, and finally ruled that Ernie could remain a Board member, and all of the motions where his vote was crucial to pass could stand because he had "**putative status**" under the law. This is because all parties acted in good faith, and the error was corrected immediately. Greg says this happens often on HOA boards and therefore there is plenty of

legal precedent. The 2019 budget, which was approved at that November meeting can remain in force.

Greg did suggest as a precaution our Board pass a motion at its March Board meeting re-affirming all motions that passed at the November Board meeting. Our legislative chair has this motion in this packet.

Both Ernie and Mountain Air have apologized for their errors.

4. Monthly Newsletter

I remain publisher of the monthly regional newsletter. This is distributed to all club presidents for distribution to their members, although I hear reports many are not doing this. Subsequently, I received permission from the AANR office to receive the email addresses of all AANR members in the region, not just the Associates. This is a 9,000-person mail list. I have not yet processed these for Mail Chimp, our distribution firm, but I plan to have this operational by the time of our Board meeting in March. All 1800 Associate members receive the newsletter announcement monthly. The newsletter (and back issues) may be downloaded from the aanrwest.org website under "News." Thanks to Cyndi and Daniele who help with the editing and feature stories.

5. Web Site & Social Media

The aanrwest.org web site continues to be improved with new written material, new photos and new written material such as the 2019 calendar and a new photo gallery. Don Giles has been particularly helpful in going over each web page and making suggestions for improvements. I continue to meet on a regular basis with our Web Master, Scott Weber, who should have the first wave of those changes in place by the time of our March meeting. Thanks to Cyndi Faber for submitting an improved Scholarship form. A more detailed report on the web site may be found elsewhere in this report packet.

6. Government Affairs (GAT)

I continue to serve as the region's Government Affairs Chair although I am actively seeking my replacement. I have recruited Ron Weimer from Southern California to be my protégé and learn how GAT works so that (hopefully) I can turn this committee over to him in the near future. Ron is also a member of the NAC Board of Directors and he symbolizes the new working relationship AANR has begun with The Naturist Society to work together on legislative issues.

We were very lucky this election year that the candidates were focused on other wedge issues (marijuana, supreme court, gun regulation, women's rights, etc.) instead of falling back on restricting social nudity to score campaign points as often happens. It was a relatively quiet year. It allowed us to make coalitions with outside groups that have similar philosophies in order to make our voices even stronger when the inevitable pushback starts up again.

7. Trade Shows

I remain Quartermaster for the moment, and all the giveaway items and the trade show backdrops and signs are at my home. I send them out as needed to the various teams doing shows around the region. Working with Marketing Chair Ricc Bieber we reduced the variety of spiffs this year and replaced a couple. All items now contain the www.aanrwest.org web site on them instead of www.aanr.com. An inventory of these items will be distributed at the Board meeting reflecting what was given out at the LA Travel Show in February, after the deadline for this report.

These items were all purchased using 2018 budget money so the final 2018 expense report will show a bloated line item since both the 2018 and 2019 spiffs were purchased the same year.

Sports giveaways were not purchased by the Marketing/Public Relations budgets this year. Sports will have to buy their own for the Festivals and 5K events, but it is hoped that committee will

coordinate with the Marketing/PR team on purchase decisions.

8. Passports

Ricc and I got the final version of the AANR West Nudist Passport books printed and we are in the process of distributing them to the clubs. Over 90 have been distributed as of this writing, a good start. We have also placed a PayPal link on the web site so people can buy them directly through us for \$10 instead of going through a club.

The interest seems to be high on the program and we expect it to take off this summer as people start visiting the participating clubs. For more, read Ricc's Marketing report elsewhere in this packet.

9. New Mexico Fund

AANR-West Director Don Giles has exchanged letter with Marian Stelts regarding the separate funds we have kept since 1992 for starting up a new landed club in New Mexico:

Jan 12, 2019

Dear Don,

I guess we must apologize for causing this problem for you. It was not done with malicious intent.

A major objective of the Land of Enchantment Naturist was to establish a cooperative landed club. When it became obvious that we were not going to succeed, **the club voted to transfer the assets to the WSA requesting that a fund be started to help any subsequent landed club to get established.** That was done. The membership regarded the hope of establishing a landed club. Ramie and I made a couple of contributions later that has been a while.

In the intervening couple of decades, no group has gotten together to form a cooperative landed club. There was talk at one time of Roadrunner's trying to establish a fund to buy land, but I don't think anything became of that.

I have talked to Ramie. We both agree that the Roadrunner Naturists are the logical club to use these funds for the benefit on nudism in New Mexico. We would like the decision to be made by the Roadrunner Board of Directors.

Thanks, Marion Stelts

Don replied:

Nudism seems to be slowly growing in central New Mexico and we will apply the funds to efforts that will continue to attract new interested people and provide activities that will serve to maintain their attention and enjoyment of this way of life.

The Roadrunner Naturists Club is certainly not in dire need of funds and therefore can carefully consider the purposes that the funds will be used for. We will continue to maintain a separate accounting for them and will keep you advised of their use.

I will inform the AANR-W Board that we agree with the decision and I will forward your email to them.

A motion to release these funds to the Roadrunner Club will be discussed at the March Board meeting.

10. Callen-Davis

As we have discussed several times, Beachfront USA, a non-AANR club may fold soon, and they have a \$25,000 Callen- Davis Defense Fund they want to preserve in a separate bank account. They have asked AANR-West to be the caretakers of this fund, with us appointing a fund administrator and a second board member to join the existing six-person board. The board will control the use of the funds independent of AANR-West for up to the next ten years, after which the organization will be dissolved, and the funds absorbed into the AANR-West GAT/legal defense fund.

Our attorney advised us not to get directly involved in the operation of this fund, nor can any AANR-West Board member serve on the Callen-David Board (past Directors or officers are okay) as it would present potential conflict-of-interest. Rather, he suggested we rewrite their by-laws to reflect AANR-West's appointment of its Executive Director, and that in ten years the corporation will fold with any remaining funds be bequeathed to AANR-West. I have re-written the Callen-Davis By-Laws to reflect these changes, subject to the approval of their Board of Directors. This is not something the AANR-West Board needs to vote on.

I have appointed AANR member David Tiktin to serve as the C-D Executive Director and Ron Weimer to serve on their Board of Directors.

11. UltraViolet Press

As discussed in earlier reports to the Board, Cec Cinder, the author of The Nudist Idea and other nudist publications has reached the age where he can no longer distribute his own books. Last summer I was asked if AANR-West wanted to take over stewardship of his books so they would not go out of circulation. After consulting with our attorney, we decided it was best that we not get into the book publishing business but try to negotiate a partnership with the Cinder-Snyder family so we could sell the books directly or through our network of clubs at their bookstores.

An inventory of remaining stock in December revealed nearly a thousand remaining books, far too many for us to store and manage. Ce's daughter has decided the family will retain control of the publication business, and will work with AANR-West, Amazon, and other distribution supply chains to sell the remaining books and republish more in the future should the demand be there.

12. Mid-Winter AANR Trustee Meeting

Walt Stephens, our Western Region Trustee, is unable to attend the February 8-9, 2019 meeting in Florida, so as Regional President I get to go as his backup. I will submit a written report to the Board when I return, and I will also have an abbreviated report ready for the regional newsletter March issue.

In Conclusion

It is very gratifying to see AANR-West is once again having a positive impact on the social nudist movement and its future. I think we have some very smart business-focused people on the board, and I look forward to reading your reports about how we will carry our vision forward.

Legal Issues

A. Dissolution of Legal Services

As stated in my President's Report, our attorney, Greg Wilkinson, has recently taken a full-time job with a corporation as their legal counsel, we discussed the dissolution of Greg's contract as AANR-West's legal counsel.

Greg said he would complete the open issues and then we will all sign a letter of termination.

Greg recommended we contact the local bar association for referrals to a small legal firm specializing in nonprofit corporate law. He suggested we should negotiate for a flat fee instead of by the hours as otherwise we will be charged for every minute the attorney reads an email from us or talks on the telephone with a board member or officer (average fee is \$30 per minute).

Greg said we may have trouble getting anyone as inexpensive as in his contract, especially when it comes to having the attorney present at the Board meetings and Convention each year (covering expenses is probably not enough as the attorney will charge by the hour to be there.)

Greg is happy to help us screen potential lawyers once we develop a list of possible candidates.

Here is a list of the other things we discussed over dinner which many clubs and individuals wanted clarification about:

B. Member vs Non-Member Income

Two of our clubs are having trouble interpreting the IRS(c)(7) and (c)(3) rules about the percentage of income limit they can receive from non-member dues. One club thinks it is 15%, and they define that as everything except the actual member dues. Under this interpretation, all guest gate fees, activity fees, etc., are not counted in the members side of the ledger along with things sold through their store. The other interpretation is the opposite, and member income is defined as everything related to member dues, club activities. "Non-member" income in this interpretation means only store merchandise, direct donations, raffle, etc. Greg gave us a clarification because the IRS rules on this subject can appear murky:

- Members paying to attend an event fall under a benefit of their membership and therefore are not subject to the 15% rule.
- Non-member guests who pay to attend an event may or may not fall into the 15% rule, so Greg recommended the clubs establish as **separate membership category for guests** to attend their events. This should be called a "one day membership" that specifically spells out what is covered (attendance at the location, ability to enjoy the facilities, rental of overnight lodging, etc.) and not covered (voting rights, discounts on merchandise, etc.).
- Purchases of raffle tickets, store merchandise, etc., will therefore fall within the 15% IRS Rule while any entrance fees will not.

I have asked Greg to write us a letter explaining this better than I can above, with proper citation of regulation and case law that our member clubs can use.

C. Photo Releases

At our meeting, we discussed the legality of posting photos we did not take (from the Internet, etc.) in our newsletter, and on our Twitter account.

- It is Greg's opinion that such photos fall into the "educational purpose" clause of the copyright law, and therefore they can be used even if no other source identification can be found. Do not use any photos clearly marked as copyrighted by a photographer or a company (i.e. Getty Images).

- He also said that if we take photos of recognizable people, we need a signed release from these people, and also from the location where the photo was taken if on private property and the location can be recognized because of distinguishable buildings or other identifiable things in the background.
- Photos taken on a public street are not covered by any “expectation of privacy” law, nor are images of people in the background of people taken at a public beach. The question came up over publishing photos taken at the World Naked Bike Ride each year.
- Seizing a photographer’s camera is considered “battery” under the law and well as “destruction of private property” if the photographer’s camera is damaged or destroyed.
- The privacy law is similar regarding drones over public places. (Private property is protected up to 83 feet overhead.)
- Persons who are nude in places where other might see easily (a neighbor’s kitchen or bathroom window, for example) makes the nude person open to prosecution for indecent exposure (or whatever the local law says) but if the viewer must take special effort to view the nudity (using a ladder to climb to top of fence, etc.) then the nudity is allowed, and the viewer is vulnerable to “peeping Tom” prosecution.

D. Legal Issues Still Open:

1. A letter from Greg explaining why Ernie Wise can remain on our Board and all decisions made by the Board while he has served maintain their legal standing.
2. A letter from Greg clarifying how the IRS interprets members vs. non-member income in a non-profit corporation.
3. Helping to incorporate the World Naked Bike Ride – Los Angeles so it can properly negotiate for permits, as the event is now too popular to just ride in designated bike lanes. The coordinating committee, of which AANR-West is a participant, also wants to negotiate for a park area where the event can be properly staged.
4. Assist in finding his replacement.

FINANCE REPORT – FEBRUARY 4, 2019

Rolf Holbach – Finance Chair

I continue to support and advise the AANR-West Board of Directors in the implementation of the 2019 budget authorized at our Fall Meeting.

In 2016 the Board granted a \$1500 loan, and in 2017 a \$1000 loan for the production of “immersive” naturist plays at the Hollywood Fringe Festival under the Public Relations Budget. “Immersive” in the sense that both the performers and the audience are required to be nude. The loans were granted in exchange for public recognition and promotion of AANR-West. Both loans were repaid with interest. Although \$1000 was budgeted in 2018, the producer, Brian Knudson, did not mount a production last year. We did not budget anything in 2019 for this because we were not sure that a project was in process at the time the budget was assembled.

Brian is now in the process of updating the script for the popular nudist play, “Barely Proper” for a possible production at this years Festival in June. At the spring meeting, we may be requesting a loan for this year’s production, again under the Public Relations budget.



GENERAL ISSUE

Coming off yet another headache with a terminally suspended account, we are keenly aware that there are individuals who find social or personal nudism as their *dragon* to slay. As with any way of life, there will always be people who are just a little too fanatical with their devotion to nudism and consider anyone not in perfect harmony with their beliefs a heretic. Speaking for all nudists using the various media platforms, we need to be not only vigilant for such worries but also be accountable for our own content. It is the responsibility of every on-line nudist to represent naturism as wholesome and family oriented in the manner as the AMERICAN ASSOCIATION FOR NUDE RECREATION prescribes.



There have been a number of situations which have come to light in the past months which are not in the best alignment with the AANR model. This director often fields complaints from other nudists who voice their trepidations about what they are finding. Concerns include: affiliated clubs who LIKE posts from dubious sources; users incorporating the AANR name in their *user name* whilst opining on non-nudity issues; tasteless comments and failed attempts at humour, just to name a few. There are several other inappropriate blurbs which, due to decorum, need not be catalogued here.

This subject has been discussed at the *corporate* level in Kissimmee to which the PR team is considering an issuance of more comprehensive guidelines. Whether as a representative for a club, resort, region or an affiliated business, we have an obligation to represent ALL our members. Of course, everybody is free to express their thoughts on current events, politics or the trending memes — nevertheless, if it is not directly affecting the nudist community, it has no place on an affiliated or one's personal *nudist* account.

TWITTER

Once again, our TWITTER outreach was suspended for unknown reasons. Just a week after our November 2018 meeting, the @AANR_WesternRegion account “required verification” but — like before — numerous attempts to learn the cause, to rectify the situation or to receive assistance from their “support team” proved futile. We speculate these attacks are from a disgruntled **blocked** follower filing malicious complaint which results in a permanent suspension with no recourse for appeal. Navigating their less-than-friendly “help” is daunting and frustrating.



We subscribe to Google Analytics so we can monitor who visits our web site, what they are looking at, etc. Below are the stats from December 1m 218 through January 31, 2019:


Gender and Age of our web site visitors: 76% of our web visitors are male. No surprise there. 45% of our visitors are between the ages of 35-44. Visitors in the 45-54, 55-64, and 65+ age brackets are each about 20% of the total.



What kind of devices do our visitors use when accessing our web site?

Just over half of our visitors use a desktop computer to view the site. The percentage (37%) of Mobile device users continues to grow as the number of Tablet users continues to shrink. This reflects national trends on the popularity of these devices among the general public.

Chrome continues to be the most popular browser used (45%) followed by the Mac Safari (24%).



What countries do our visitors come from? What are their interests (what other kinds of web sites do they visit?)

The United States continues to be the location of the vast majority of visitors (67%) with China, Canada, United Kingdom coming in next.


The Analytics program also examined the “cookies” of the visitors to determine what other web sites they look at. The chart below reveals these preferences, which are scattered among many categories.



What pages are visitors looking at first?

Well over half of our visitors come in through the Home page, while the Club Directory and the Photo Gallery come in second and third. Interestingly, the article on nude hiking is in fourth place so people must be coming here through a search engine query. Activities is in fifth place.

However, about 60% of our visitors look at more than one web page so an analysis of the viewing flow chart reveals more about user preferences:



Those who come in through the Home Page next go to the Directory, Photo Gallery, and Calendar about equally, The First Timers menu comes on fourth place at about 10% of all viewers.

Also looked at are the Government Affairs page, Youth, and sports, which is where we hoped they would go. So it seems we are organizing our work well and we are providing useful information our visitors want to read.

Director's Report for Spring Board Meeting, Lupin Lodge March 2019
Membership Marketing

A lot has been accomplished in the last few months. Give-a ways have been ordered and received, shows have been or are being set up, and looking forward to Convention!

Spiffs: We have received all of the Give-A-Way items, or spiffs, that were ordered, which include emery boards, beach balls, flashlights, lip balm and pens. We deal with AnyPromo for these items, as their prices are very competitive, and the service/delivery time is exceptional. They are a very professional business to deal with, and are local to the West. We will have samples at the Board Meeting for your perusal.

If need be, we will order more items as they are needed, but we anticipate that the quantities ordered will last through the season/year. We will also keep an eye on which items are the most popular, and adjust as needed. Additionally, if you have an idea for a Give-A-Way, please let me know, and I can look into it for future reference.

Upcoming Shows: We are set up, and are setting up, to participate at the following tradeshow/exhibitions; L. A. Travel Show in February, CPRS in Sacramento in March, and Earth Day in San Diego in April. We are pretty well set up as far as manpower and materials, and have very competent people leading the charge at each venue. We have done very well in the past at these shows, and look forward to making a great showing again this year. If you are interested in helping out at the various venues (Los Angeles, Sacramento, San Diego) contact us and we will forward your interest to the appropriate person in charge of the particular show.

We do need to update a couple of the portable backdrops we use at the shows, as some information has been adjusted, or because of use/damage to what we are now using, and that should occur as of the submission of this report or thereabout. We are also looking into making a duplicate set of backdrops as a cost-saving measure to avoid shipping the one set all over the place. Life expectancy on this item is usually 4-7 years, depending on use and the need to upgrade any information. We get the best price through Vista Print on this item.

Passport Program: The Nudist Passport Program is in full swing! The Program has been presented to the Clubs, and the response so far has been terrific. So far, 81 Passports have been distributed at various events around the region. We are waiting to hear from the large landed clubs-they have been contacted. Most of the action has been from either individuals or travel clubs. AANR Head Office has expressed interest in this program, and we'll see where that goes. We are making this program available to the other regions as our program progresses, so it should be interesting.

In order to facilitate broader participation within the region, a PayPal account has been set through the new and improved Website (detailed elsewhere). This should make it easier for those who may not have direct access to the Passport Program to obtain it for their use and enjoyment.

We are also offering the Clubs the option to have us provide a unique Passport stamp for the Club's use, at cost, (about \$12-15.00) to make participation easier.

SPA Events

I invited people to my "birthday in your birthday suit" celebration at a local Korean day spa called Aqua Day Spa for Thursday, January 24th, after work 5 pm or 6 pm until closing around 10:30 pm to relax. A talk about ladies issues on the Ladies side of the spa was scheduled for 7 pm. Even though I had extended about 15 individual invitations to ladies local to San Diego, they dropped like flies on the actual day of the event even after having a Yes RSVP on Meetup and with me on WhatsApp, where I had invited several newcomers. Having a cold, pneumonia (1 lady!) or being exhausted were the most common excuses. I tried to explain that time spent in a steam room and inside a Red Clay Himalayan salt room would actually help all these conditions, but only one lady showed up. I did however manage to chat up a Russian lady and a Ukrainian lady who had lots of questions for me. I had AANR West brochures with me, and wore my director badge name tag, when not in the wet areas.

Even though only one lady actually showed up, I plan to ask my committee members if they agree with me to raise attendance by making it an AANR West membership benefit coming from the WINR budget. I am thinking of covering the \$ 20 all-day pass fee for any AANR members or those who fill in the AANR membership brochure (I have paper versions with me). I would like to make this a recurring monthly event that can attract new members.

I plan to organize several more Ladies Spa events in the OC and other locations, including Albuquerque, if I can arrange it with Treena's help.

Unfortunately, the coed SCNA spa event 2 days after my birthday was sold out before I got to the RSVP list, as it is quite a small facility, so I was unable to catch up with Ricc and Rolf, as I had planned to. My son Alexander (12) had very much hoped to go as well to see his young naturist friends. I will RSVP sooner, and search for the events more carefully in advance.

I still think that unisex Spa Events can generate new lady members, as the ladies are already naked at the spas, and I need to only tell them about AANR and more opportunities outside spas to also go to clubs. I always have brochures with me, and hope to receive my AANR West cards soon.

While attending a photo event with Jack Gescheidt of TreeSpirit near the Clothing Optional Bed and Breakfast run by Rolf and Cynthia, I talked to several ladies with leads on spa locations in the OC and LA.

Meetup allows organizers (group owners) to freely choose group members and turn them into hosts for events.

Whereas, it is the responsibility of the AANR-West Board of Directors to follow its Bylaws and to ensure Directors are elected accordingly, and

Whereas, Mountain Aire Ranch is a 100% AANR membership club and pays its members AANR dues from the membership fee collected from its members, and

Whereas, Ernie Wiese has been a continuous dues paying member of Mountain Aire Ranch since prior to 2014, and

Whereas, Ernie Wiese was elected to the AANR-West Board of Directors for a two-year term by the AANR-West Regional Assembly on July 29, 2017, and

Whereas, Ernie Wiese's election was done in good faith that he was a current member of AANR due to his membership in Mountain Aire Ranch, a 100% AANR club, and

Whereas, Ernie Wiese's AANR membership lapsed due to a self-admitted clerical error of Mountain Aire Ranch to pay Ernie Wiese's annual AANR dues, and

Whereas, Mountain Aire Ranch's clerical error and Ernie Wiese's lapsed AANR membership was not discovered until after the Fall, 2018 meeting of the AANR-West Board of Directors, and

Whereas, Ernie Wiese's current and back AANR dues have been paid in full to AANR, and

Whereas, Ernie Wiese had putative status as an AANR-West Director until the lapse of his AANR membership was discovered after the Fall 2018 Board of Directors meeting.

Therefore, be it resolved that Ernie Wiese is a duly elected Director of AANR-West and the actions he has taken as a Director of AANR-West is affirmed by the Board of Directors of AANR-West, specifically:

- o Motion #5 (amends Procedure Manual Section 7.02.00 regarding reimbursement for lodging by board members attending board meetings or conventions), and
- o Acceptance of Lupin Lodge as the site for the March 2, 2019 Board meeting and acceptance of Shangri-La Ranch as the site for the November 2, 2019 Board Meeting, and

Motion #6 (acceptance of the 2019 AANR-West Budget).

Rationale:

Prior to this meeting our attorney sent us a legal opinion that we do not have to remove Ernie Wiese from our AANR-West Board even though technically he was not an AANR member since 2014 when everyone thought he was a member paid through his AANR club, Mountain Air Ranch, which requires 100% of its members to be AANR members also. Our attorney cited case law that:

- Defined Mr. Wiese as having “**putative status**” which means because all parties acted in good faith, all he must do is pay his current dues (back dues are optional but recommended) and he can remain on the board.
- All Board motions and resolutions made last November should be reaffirmed with a simple blanket resolution at the March 2019 Board meeting. The budget, which was approved at that November meeting can remain in force and a special Board meeting to re-pass the budget is therefore not *necessary because of this “putative” legal status.*
- This resolution describes what happened, how it was solved, and asks the board to reaffirm its support for Ernie Wiese as a member of the AANR-West Board, and specifically for his votes on:
 - Motion #5 (amends Procedure Manual Section 7.02.00 regarding reimbursement for lodging by board members attending board meetings or conventions), and
 - Acceptance of Lupin Lodge as the site for the March 2, 2019 Board meeting, acceptance of Shangri-La Ranch as the site for the November 2, 2019 Board Meeting, and
 - Motion #6 (acceptance of the 2019 AANR-West Budget).

The above actions previously taken by the AANR-West Board are the only ones affected by Ernie Wiese being a member of the board since his election 7/29/2017.

Fiscal Impact: None if passed otherwise the listed actions from the Fall 2018 BOD meeting must be revisited by the board.

I enlisted in the military and used the system to get a basic education in what was to become my life-time trade. I did not do a single day of a college or university. Therefore, I had no specific reference on how the registration process worked, let alone how to streamline it in our case. Cyndi understood the specifics and adapted our new program accordingly.

We can rest assured that AANR West is well positioned to grow our new scholarship program from this point forward.

The two primary changes are:

- 1) Streamline the application process by providing the application process can be completed online.
- 2) Allowing for AANR West to cover those who want to attend a college or a vocational or technical training school, at any age. Therefore, active members may also take advantage of this program, as well as their families and children.

Granted that the parents are often the primary source of paying for a college level education, and AANR West fund certainly help, but we as an organization recognize that not every member may be financially responsible for a child in college. We are addressing the possible need for an adult member to request assistance also for additional educational or vocational training.

Expenses for growing this program are negligible. But the potential for us to give back to the clubs who fund us through their membership requirements, could be huge through the vocational option. It is a direct win-win situation.

We would suggest the Board consider expanding the funding of the program at the next annual BOD budget meeting to address the continuing education program. At this point we offer the program on our WEB site, but there is no specific dollar amount available.

The next report to the Board will have specific results available since we have just begun as of January 1, 2019, so we will have actual applications to report for the coming year.

Government Affairs Report – February 2019

California Parks and Recreation Show (CPRS)

AANR-West has a booth at this annual trade show. This year it is in Sacramento, March 20-21. It attracts employees and supervisors from the various parks each year, plus an occasional legislative staff member. It gives us an opportunity to discuss social nudity in general but also to advocate for designated places within the park system to be set aside for clothing-optional use.

We have updated and are reprinting the two Government Affairs brochures for this show.

U.S. Public Lands Deregulation

Several bills were introduced in the U.S. Senate this year affecting recreational areas in California and Utah where nudists like to hike and camp. They deal primarily with land transfers between Federal agencies and redefining the boundaries of existing Federal wilderness areas so that more of these protected lands can be used for oil drilling mining, cattle grazing and other farm or agricultural use.

- Senate Bill S2809 (Hatch-Utah) affects over 500,000 acres in Utah are designated as national wilderness areas, including Candland Mountain, Crack Canyon, Desolation Canyon, Devil's Canyon, Horseshoe Canyon (North), Mexican Mountain, Muddy Creek, Nelson Mountain, San Rafael Reef, and Sid's Mountain.
- Senate Bill S140 (Flake -Arizona) amends the White Mountain Apache Tribe Water Rights Quantification Act of 2010.
- House Bill HR 857 (Cook-CA) This bill amends the California Desert Protection Act of 1994 to reduce its size and to allow off-road vehicles (ORV) in previously protected areas.

None were heard by Congress committees before it adjourned, but the Trump Administration went ahead and designated many of these proposals via revised regulation and executive order.

During the past year, the Trump Administration has reduced the size and number of many designated wilderness areas via revised regulation and executive order.

Because we lack the financial ability to retain a lobbyist or make the necessary political contributions, AANR is basically powerless to stop or amend any of these proposals. We will continue to monitor these proposals and regulations and report back on any future changes.

NPS - Saline Valley

The National Park Service completed and released its long-anticipated report recommending changes to the Death Valley National Park and adjacent areas under its jurisdiction, including the traditionally clothing-optional Saline Valley Hot Springs.

To our relief, there were very few changes recommended to this remote and under-developed Springs except to officially approve the makeshift airstrip called the "Chicken Strip," basically a strip of flat dirt used by people to access the Springs who do not want to drive the bone-crushing four-hour drive on a 50-mile long rutted dirt road to get there.

After first advocating its removal, NPS has now agreed the "Chicken Strip" will stay and be improved, thanks to the efforts of the local Recreational Aviation Foundation (RAF) whose volunteer members will become responsible for its upkeep.

AANR member Peter Connolly visited the area in October and he said all the clothing-optional hot tubs, built there over the years, will remain as will some of the non-indigenous plants such as the Palm trees once threatened with removal. The park superintendent has adopted a live-and-let-live attitude toward the traditional nudity there.

Both the difficult access and the lack of improvements means the place will never become a major tourist destination - so much the better for both the handful of residents and nudist visitors!

WNBR-Los Angeles

The annual bike ride through downtown Los Angeles is slated for Saturday June 22. The organizing

committee consists of representatives from the two local clubs plus AANR-West and The Nativist Society, and this year the group is incorporating so they can obtain a parade permit from the city. The reason is the ride regularly attracts 3650-400 riders and this is too many for the regular bike lanes. We need a formal organization to request a staging area in a public park (as is done in Portland) and to have deputies block traffic at intersections. All sponsors get information tables in the staging area and we always hand out literature and some siffs to those interested.

WNBR - Cathedral City, CA

On December 16, the newly elected mayor of this small town located near Palm Springs in the Coachella Valley proposed the city sponsor a World Naked Bike Ride there in April or May of 2020. The local Desert Sun newspaper article said the City Events Manager, Chris Parman, favored the idea but said a special use permit will have to be issued by the city and routine coordination with local law enforcement would be necessary. Parman added that, if approved, the ordinance of public nudity for the bike ride will be waived for that day. Mayor Greg Pettis, the city's first openly gay mayor, got the local Rotary Club to commit to co-hosting the event and public hearings were scheduled for after the first of the year.

Unfortunately, on January 16, the mayor suddenly died from complications related to gastric bypass surgery. We don't know where that leaves the proposal. After an appropriate mourning time, both AANR-West and NAC plan to approach the new mayor to see if the idea is still alive.

California's Sexual Harassment Law Strengthened

For many years, the relevant provisions of California's Fair Employment and Housing Act ("FEHA"), sections 12950 and 12950.1 of the California Government Code, require employers with 50 or more employees to provide sexual harassment training for all supervisory employees. As of January 1, 2019, the law requires employers of **five or more** employees—including seasonal and temporary employees—to provide sexual harassment training for both supervisory and non-supervisory employees.

AANR-West will send emails to all landed club managers in the state to make sure they are aware of this change and make sure their club complies.

Utah Theater Owner Wins Lawsuit

Lawmakers and the governor in the conservative, predominantly Mormon state had backed a law that is largely aimed at strip clubs but also prohibited serving booze during films with simulated sex or full-frontal nudity.

Until now.

A movie theater sued in 2016 after Utah regulators threatened to fine it up to \$25,000. The state defended the measure in court, calling liquor and sex an "explosive combination"

In September 2018, after a lengthy trial, a Federal judge struck down the law last year as a violation of First Amendment rights, ruling the theater is not an adult-oriented establishment, and *Deadpool* is a mainstream, R-rated movie. The judge ordered the state to pay more than \$475,000 in legal fees after it lost a court fight over a law that banned serving alcohol during the racy, foul-mouthed superhero film *Deadpool*.

Liquor authorities were concerned about a suggestive scene in the film's credits involving a cartoon unicorn, among other things. The theater's attorney and former Salt Lake City Mayor Rocky Anderson argued that the law was so vague it would apply to Michelangelo's "David."

His office was awarded attorneys' fees and an additional \$3,800 in other legal costs. *Deadpool* star Ryan Reynolds held a fundraiser that raised \$22,000 for the plaintiffs, and this was deducted from the final financial award.

Idaho lawmakers repealed a similar law last year when a theater sued after its liquor license was threatened for showing *Fifty Shades of Grey* while serving alcohol.

Hawaii Bill Would Extend Penalties for Drone Photos of Nude Persons

Just introduced 01/16/19 - HI 2019 HB 13 This legislation seeks to increase the penalty for “violation of privacy” from its present status as a misdemeanor - to a class C felony, if:

- a. The person intentionally or knowingly installs or uses, or both, in any private place, without consent of the person or persons entitled to privacy therein, any device, including an unmanned aircraft system, for observing, recording, amplifying, or broadcasting another person in a stage of undress or sexual activity in that place; or
- b. The person knowingly discloses or threatens to disclose an image or video of another identifiable person either in the nude, or engaging in sexual conduct, without the consent of the depicted person.
- c. This paragraph shall not apply to images or videos of the depicted person made when the person was voluntarily nude in public or voluntarily engaging in sexual conduct in public.

Analysis: If the bill becomes law, it might allow prosecution of a drone-flying voyeur who hovers his device over a backyard skinny dipper or nude sunbather, or if a drone camera looks in a window of a residence. But the bill does nothing for a publicly nude person on a public clothing-optional beach. The annoying drones on a public beach will still be legal. It is too early to decide whether naturists should support this bill or oppose it, as similar bills in the past have rarely made it out of committee. We are watching it.

HOW DID THE 2018 MIDTERM ELECTIONS AFFECT NATURISTS?

The Government Affairs Team (GAT) is still assessing the effects of all the various state changes that occurred as a result of the November 6 midterm elections.

Some interesting factoids from this year’s election:

- With Idaho and Utah voting yes, it is finally the law in every state that mothers can legally breastfeed in public.
- With the defeat of Gov. Scott Walker in Wisconsin, local nudists have emailed me they are hopeful the new Democrat administration will be more open to the restoration of the clothing-optional area at Mazo Beach, which Walker closed several years ago.
- “Trifecta states” (where one party controls the governorship and both houses of the state legislature) saw a net gain of six states for the Democrats. The current count is Republicans have 22 trifectas and Democrats hold 14. This means essentially “one party rule” in those 38 states.
- The only state left with a divided legislature is Minnesota. The remaining 49 state legislatures are all controlled by one political party or the other. Of those states, Democrats control 18 legislatures while Republicans control 31.

Some of the new legislative sessions will begin in December and others in January or even later. We will be watching for bills that affect nudists, and we will report these to you in future newsletters. Here is more election information about our region’s individual states:

CALIFORNIA

This state remains the “bluest” of the “blue” states, with Democrats holding all statewide elected offices, and holding a 2/3 majority in both the State Assembly and State Senate. New bills can be introduced starting December 1.

Fifty-three members of Congress come from California. The election flipped four of these seats from Republican to Democrat, so the count is now 40 Democrats, 13 Republicans, depending on if there will be any recounts.

U.S. Senator Diane Feinstein (D) easily won reelection to her sixth (and probably her last) term. At

age 85 she is the oldest and the longest current serving member of the Senate.

The CA legislature came back into session at the start of the new year with hundreds of bills already introduced. Nothing looks like it affects nude recreation for now.

ARIZONA

Arizona remains a Republican “trifecta” at the state level. Republicans control the state Senate with 16 seats to Democrats' 13 seats. Republicans control the state House with 28 seats to Democrats' 26 seats with two not yet decided.

Republican Rep Martha McSally was defeated by Dem Kyrsten Sinema for the U.S. Senate seat previously held by GOP Sen. Jeff Flake. In mid-December, the other US Senator from Arizona, Jon Kyl, decided to resign. He was appointed to fill the seat held by John McCain until his death this past August 25. The governor decided to appoint McSally to the seat, so both Senate candidates now represent Arizona. McSally must stand for re-election in 2020.

The state's nine U.S. House seats remain split between five Democrats and four Republicans, a net gain of one for the Democrats.

COLORADO

The Democrats kept the Governorship in their column, and they also picked up a Congressional seat making that count now four Dems and three Republicans, with one not yet decided as of this writing. Congressman Jared Polis will be the country's first openly gay man to serve as governor.

Colorado's State Senate flipped with 18 Dems and 17 Republicans, while the state House now has a Democratic majority 37-23, a net gain of four for the Democrats.

HAWAII

Hawaii has been a Democratic trifecta for many years, controlling all state elected offices, and both state houses by wide margins. The party won the single US Congressional seat by a 50% vote margin, and Sen. Mazie Hirono was re-elected to the US Senate by a 71% margin over her Republican opponent.

Note: The closest AANR came to problem legislation this year was in Hawaii with HI 130, which asked for an investigation of all nude beaches. The bill died in committee without a hearing for the second year in a row. We will be watching to see if the same legislator tries for a third time in 2019.

NEW MEXICO

The Governor's office flipped to the Democrats this year, and all the other statewide elected officials are also now Democrats. Democrats control the state Senate with 26 seats to Republicans' 16 seats. Democrats regained control of the State House in November 2016 and increased their six-seat margin to 22 with two still undecided.

The U.S. Senate seat remained in Democrat hands by a 54% to 30% margin. New Mexico has three U.S. Congressional seats, and the Democrats now hold all three after flipping the last one.

NEVADA

The Democratic "blue wave" hit was never more evident than in Nevada this year, with Democrats taking the Governorship for the first time in two decades and toppling the incumbent Republican U.S. senator.

However – only in Nevada! - a brothel owner and reality TV star, Dennis Hof, who died a month before the election, still won his race for Nevada's 36th Assembly District. Hof, who ran as a Republican and calling himself “The Trump of Pahrump” defeated Democratic challenger Lesia Romanov by more than 7,000 votes, proving the old cliché that some people would rather vote for a dead man than for someone from the opposition party. According to state law, county officials will

appoint a replacement, but as of this writing, this has not yet happened.

In other Nevada news, the **Burning Man Festival**, held August 26 – September 3. Nevada courts have maintained that simple public nudity in Nevada, outside specific types of businesses set aside for it, may be charged with both indecent exposure and open/gross lewd behavior for the same offense. Despite this, deputies did not cite any Festival participants for nudity, despite there being many hundred people there who were openly nude. Arrests were made for drug use, however.

UTAH

Utah remains a Republican trifecta, controlling the governorship as well as a majority in both the state Senate and state House (58-17 seats) although the Democrats had a net gain of two seats in the lower house. Former Republican Presidential nominee Mitt Romney won election to the U.S. Senate with 62% of the vote.

WYOMING

Wyoming is also a Republican trifecta, with that party holding the governorship and a wide majority in both the state Senate and state House. The Republican U.S. Senator was re-elected easily, as was the state's sole member of Congress, Liz Cheney, daughter of the former U.S. Vice President. The state's legislative session starts February 12.

Liaison Reports

Friends of Bates Beach

After 28 years on the Carpinteria City Council, its longest serving incumbent, Brad Stein, lost his bid for re-election on November 8 by 301 votes. He will be replaced by newcomer Roy Lee at the end of the year. Two incumbents (Gregg A. Carty and Al Clark) were reelected.

Stein was a supporter of our clothing-optional section at Bates Beach. Lee, 37, is co-owner of the popular Uncle Chen restaurant in town. I spoke to him about the beach at a candidate's forum in October, and he was open to hearing more about it. The fifth candidate for city council, Dar Ringling, head of the local Republican Party, came in dead last in the voting. At the same Candidate's Forum, he told me a flat "No" when asked if he was open to our use of the beach.

A meeting with the Mr. Lee is pending.

Mayor Fred Shaw, a friend of the nude beach, rotated out of office and was replaced by Councilmember Wade Namura, who is far less friendly. We don't know what this means for stricter law enforcement on the beach, but I am in the process of arranging a meeting with him in another month or so to hear if the verbal agreement with the city has changed.

Meanwhile, a new round of Beach Ambassador training is scheduled for mid-April. Books have been printed, and classes will be promoted in the local newspaper in March. Monthly Meetup dinners for local residents of Santa Barbara County will resume in Carpinteria in April.

Olympian Club

This club, founded in 1952, was on the brink of going out of business last Fall as its membership had dropped from 250 a few years ago to just under 30 today. What is left of the membership lives in Orange County near Tustin and in Riverside County just to the north. The average age is over 80. A meeting was called in November to decide its future.

SCNA Board member Robert Young, who lives in the south Orange County area attended the meeting and invited the Olympian members to several of the nudist events being held by NitOC and SCNA, the two nearby nudist clubs. Apparently, the members were not aware of activities outside their own occasional pot luck dinners despite having this information sent to their club president every month. They were quite interested! At the meeting, the members rallied and decided to give the Olympians another chance. Young has joined their Board and will be attending their meetings to be sure these outside opportunities are communicated.

Southern California Naturist Association (SCNA) Liaison Report

The SCNA is still the largest non-landed naturist club in California with 140 paid members plus a mailing list of approx. 450. It is affiliated with both The Naturist Society and AANR, but dues for these two national organizations are voluntary. Currently 31 members also belong to AANR and about 30 also belong to TNS, with perhaps a dozen people overlapping and belonging to both. SCNA annual dues remain at \$90/individual or \$115/couple.

All members and event guests undergo a background check before admittance to events or before being accepted as participating members of this non-profit California Corporation.

The SCNA slowed down for the holidays with our traditional **Pre-Thanksgiving Party** in November, and for the third year in a row photographer, Jack Gescheidt, came to our Arroyo Del Sol B&B to take

TreeSpirit Photos up the Gabrielino Trail in the Angeles National Forest with any nudists who wanted to participate. His photo from the 2017 session at Arroyo Del Sol made the cover of the Summer 2018 (#37.4) "N" magazine and can be seen on his website at treespiritproject.com.

Our only clothed party of the year, was our **Holiday Party and Awards Banquet** in December. We normally use these months to survey our membership getting their feedback on what they like and don't like about the club and the events we host. It gives our Board of Directors a good direction in how to plan for the following year. We have found that the majority enjoy us offering a variety of new and traditional activities to our members, inviting and including members of other local affiliated non-landed clubs which continues to attract new naturists to the SCNA. The result is that our paid membership has remained at a solid 140, due to some membership churn related to some aging members. We have increased followers on our Meetup.com page to 2081, and have 11,800 followers on Twitter, and 592 Facebook members.

We started 2019 off with two great events. On January 12, the SCNA returned to the fabulous Getty Museum in West LA where we held our **Nude Scavenger Hunt** where contestants roamed through the pavilions answering questions about the nude artwork and sculpture. This year the Getty featured a great exhibit on "Renaissance Nudes" which brought out many new people to our event. On January 26, almost 50 SCNA and NitOC members met at a Korean-style spa in Torrance for a **Nude Spa Evening** to enjoy the various pools, saunas, massages, and body scrubs. Normally the spa is limited to Men Only, but as the owner is an SCNA member, he closed it and allowed both men and women, to enjoy the facilities.

February began with our traditional **Super Bowl Chili & Soup Cook-Off Party** at a member's fabulous football party house in Victorville. February 9th will see our first **Women's Only Event** of the year by the SCNA ladies who've dubbed themselves the "Dragonfly Ladies". 2019's first show of the body positive productions at the Two Roads Theater in Studio City sponsored by AANR, the SCNA, and the Clothing Optional Home Network will take place later that same evening. This show is a well-attended **Nude Stand-up Comedy Show**. As with all the shows presented by the **NudeComedyLA** group at the theatre, these are all inclusive naturist experiences where the audience as well as the performers are all required to be nude. At each show, this is the **first** social nude experience for many attendees! The following weekend of Feb. 16-17, several members of local clubs and resorts will head to the annual **Travel and Adventure Show**, held at the LA Convention Center, to help staff the AANR-West booth there. The SCNA has added two new events this month. The first is a "**Pinball Wizard**" **Nude Retro Arcade Event** where we've rented out a video game arcade on Feb. 23. The next evening we'll have a **Nude Academy Award Viewing Party** where prizes will be given to the person who guesses the most winners correctly.

Spring will arrive for the SCNA on Saturday, March 16, for our **St. Patrick's Day "Think Green" Party** theme at a member's home in which a Best Salad contest is held. Sunday, March 24th will see us hosting our first **Nude Bowling Party** of the year, a multi-club event which is so popular it draws naturists from all over Southern California, even as far as from San Diego.

On Saturday, April 6th, we'll have a "**Nothing But Net**" **Nude Game Party** at a member's home. The following weekend we'll join up with members of NitOC and the Camping Bares for a hike down to **Deep Creek Hot Springs**. Various members will participate in, or spectate at, Olive Dell's increasingly popular **Bare Burro 5K Run** on Sunday, April 28, and participate in their **Naked Beer Mile** race the day before.


