President – Reviews the Agenda for this session.

• The delegate from CANYON STATE NATURISTS, Craig Watts, is now present and his credentials are certified.

**Marketing** – Handles brand management, placement and design of advertising, logos, trademarks, promotional brochures and other literature, giveaway items, and tchotchkes.

- Ricc Bieber stands by his reports as submitted.
- The region's supply of spiffs is plentiful, in that most all the trade shows and other public outreach activities were cancelled this year.
- The one bright spot is Jeff Tendick's new membership drive which has been successful given the situation. The new items he brought forth are popular and have been the *deal maker* with some of our newest members.
- **Spanish Translation** Creates and maintains published materials to provide positive information to members and potential members who may be more comfortable communicating in Spanish.
  - We, as a region, saw an opportunity to create outreach with the Spanish-speaking community to complement our connection with La Federación Nudista de México AC. Our trifold pamphlet has been translated and is in review.
- **Passport** Encourages visits to multiple destination clubs and events groups throughout our region, and oversees passport printing and distribution so members may participate in an annual raffle at the Regional Assembly.
  - Of the 300 passports printed, all but two were distributed. They were well received by members and the program was successful first outing.
  - The printing of the 2020-2021 passports is delayed until after the new year since many of the destinations and groups are still in lockdown mode or limited to the number of admissions each day. Suggestions for revisions to the layout have been made and the list of venues will be updated.
  - **President's Note**: The urgency for a Spanish language brochure was tempered since the trade shows and festivals have been cancelled this year.
  - Secretary's Note: This committee's report is found as an addendum to the Report Packet.
- Women in Nude Recreation Promotes a positive experience for women with the goal of increasing female interest and ultimately membership in Nudism for the region.
  - Treena Saavedra stands by her report as submitted.
  - WINR introduced a QR code printed on stickers which then can be placed on water bottles, message boards and other places. It simply says, "WINR," along with the graphic which hopefully piques their interest. People can scan the code which takes them straight to the region's women's page. A new code will be printed when the new website is introduced.
  - The SOUTHERN UTAH NATURIST SOCIETY is interested in having WINR conduct a women's seminar for them. In additions to the SUNS' request, the committee would like to hold on-line *Go-to-Meeting* gatherings where women can participate and ask questions in the comfort of their homes.
  - A rack card and brochure were introduced and distributed at the March 2020 Board Meeting. The goal is to feature only AANR-West members' photographs in our collateral.
  - **Director Rolf Holbach's Note**: The women of SOUTHERN CALIFORNIA NATURIST ASSOCIATION get together on a quarterly basis, either on-line or sometimes in person, and is facilitated by Cynthia Holbach. If the committee members would join the discussion from time to time, it would help make a positive connection.
- Inclusion Advocates compliance with the non-discrimination policy at the club level as stated in AANR By-Laws, Section I, Article IV, Part A.
  - Jeff Tendick stands by his report as submitted.
  - This is a benefit to the clubs in that it presents an opportunity to grow. This initiative is well suited for the liaison program where a one-on-one communication with the club representatives would be effective.

**Sports** – Handles all sports and recreational events at regionally sponsored functions, and maintains the rules book in harmony with the AANR Sports Manual.

- Curt Flynn stands by the reports as submitted by Barry Nielsen and Claudia Kellersch.
- Barry Nielsen reached out to the clubs' activities directors and received hardly any responses. The committee will reevaluate the volleyball, pickleball, billiards, horseshoe and other tournament rules in our Procedure Manual to assure they are standardized and current.
- Discussed at the March 2020 Board Meeting was the idea of having inter-club competitions within the individual states of the region (maybe split Northern and Southern California).
  - **AANR-West Trustee's Note:** Revise the rules to be somewhat flexible, so they need not require constant rewriting, i.e. "six to nine-man teams" instead of "six or nine ...."
  - *dÁS Delegate Gary Holden's Note*: The rules for volleyball at DE ÁNZA SPRINGS were revised two years ago.

Government Affairs - Conducts business in accordance with the AANR Governance Manual.

- Tim Mullins stands by the report submitted by Gary Mussell.
- The commissioners in S<sup>t</sup> Lucie County (Florida) voted four-to-one in favor of clothing-optional status for Blind Creek Beach. Most of the beach area is owned by the state and the county will work with *Treasure Coast Naturists* to create the boundaries and a list of improvements needed at the beach, including signage.
- AANR Florida Region has a lobbyist who works in conjunction with AANR and the Tallahassee offices to find supporters of nude recreation. There is even a link on the Visit Florida website to help people find clothing-optional venues within the state!

**Conventions & Facilities** – Attends to matters related to regional gatherings, including timing, bids, site selection and arrangements. The chairman also solicits sponsors for the award plaques presented at the Regional Assembly.

- Jeff Tendick stands by his report as submitted.
- Bids have been received for the Spring Board Meeting, Summer Festival, Fall Festival and the Fall Board Meeting. A single bid from SHANGRI LA RANCH stands for the 2021 AANR Western Regional Convention. Voting will take place once the convention delegates have been affirmed.

**Nominations** – The Vice President receives nominations for officers and directors, and presents the nominees for voting at the Regional Assembly.

- Jeff Tendick stands by his report as submitted.
- The committee still has six nominations for the open director seats: seeking a first term are Dave Ziegler, Don Hubbard and Linda Weber; standing for re-election are Treena Saavedra, Larry Gould and Curt Flynn.
  - **President's Note**: The floor is open for additional Directorship nominations. "Oyez! Oyez!" The floor remains open until the time of election.
  - Secretary's Note: This is a virtual repeat of the committee report presented at the end of Friday's session.

Youth Under 18 – Oversees all matters pertaining to activities for the children of members and perspective members.

- Claudia Kellersch stands by her report as submitted.
- The original assignment was for Claudia to chair both the <18 as well as the 18-30 committees; in November, the chairmanship of the latter was reassigned to Rolando Mantilla.
- The last Youth Camp was held at MOUNTAIN AIR RANCH facilitated by Jeff Tendick, Cyndi Faber and Ernie Wiese.
- A lot of planning, budgeting and scheduling went into creating a Youth Camp for 2020, including a roster of kid councelors. Then, the state closed the beaches, restaurants shuttered, pools were not allowed, travel limited, and parents became concerned with the lockdown situation. The planning, budgeting and scheduling was all for naught.

**Young Adults** – Aims to increase the positive experience of nude recreation to persons between the ages of 18 and 30, with the goal of increasing the number of members in this age range within the region.

- Gary Mussell vouches for Rolando Mantilla and stands by the report submitted by Ricc Bieber.
- This committee was not productive this year for all the circumstances.
  - **Treasurer's Note:** In attendance via GtM is Timothy Sargent from the Los Angeles area. As a member of the AANR Public Relations Committee, he has organized a Facebook page which evolved from the Youth and Diversity Advisory Subcommittee started by AANR.
  - *Member Timothy Sargent's Note*: In working with Ronna Krozy's PR Committee, he spearheads a group of young people who discuss ideas, things which are important to millennials, areas needing improvement, and bring them to AANR. Evan Nix is also on the Y&D subcommittee.

## Western Nudist Research Library – Acts as a liaison for the WNRL's Board of Directors.

- Rolf Holbach stands by his report as submitted.
- Four collections of naturist media are involved in the *Nudist Research Library Consortium Project*: the WNRL at GLEN EDEN SUN CLUB (California), the American NRL at CYPRESS COVE (Florida), the Willamettans' RL (Oregon) and the Naturist Education Foundation RL (Wisconsin). These libraries are working together to share their material.
- With the passing of Rich Hirst, a lot of internal information was "locked" with passwords which no one else knew. A re-organization meeting was held, new officers elected, a new Board of Directors seated which includes Rolf Holbach and Evan Nix and new policies discussed. Most of those files have since been recovered or recreated.
- An important task which continues is the digitizing of movies, magazines and other material from our history. A lot of researching and archiving has gone into organizing the vast amount of media. A request was sent to the Treasurer to have half of the budgeted \$2000 WNRL donation be earmarked for the expressed purpose of funding the digitization of the library's film collection.
  - *Member Evan Nix' Note:* Responding to Larry Gould's query, there are different sized films in the library. Most are 8mm which are consumer level stock and easily transferred using a film scanner at minimal cost. Other films are 16mm that will require a professional vendor.
  - **GESC Pres. Steve Spencer's Note**: For those involved with the library, GLEN EDEN SUN CLUB and its Board fully support the WNRL. The building is on the club grounds and there is a close relationship with the staff as they move forward in the transition to a new era after Rich Hirst's departure.
  - *Member Linda Weber's Note:* At her encouragement, the ANRL now has a presence on social media. Linda is volunteering to be on the WNRL Committee to continue her promotion of the libraries.

- Secretary's Note: Since two delegates are representing SOUTHERN CALIFORNIA NATURIST ASSOCIATION and by proxy OLIVE DELL RANCH, only Rolf Holbach's e-mail reply will be accepted. Ballots are sent at 10:53 AM AST.
- Vice President's Note: Director Ernie Wiese made telephone contact after finding a "hot spot" in the Rockies.
- AANR President's Note: Two other regions have also conducted a hybrid Assembly this year with similar challenges with multimedia connections. Ralph Collinson is the new AANR-Florida President, AANR Western Canada has yet to meet and one region has cancelled their Assembly. AANR Southwestern met at OAKLAKE TRAILS with all but five attendees present at the meetings and no one got sick! The positive spin is that it seems people are either deciding to be clothes-free at home or cannot go to where they normally are nude. Overall membership is down slightly but, financially, AANR is good. One of the regions is having trouble keeping events group members motivated so AANR is looking into on-line social gatherings.
