## **Youth Under 18** – Claudia Kellersch stands by her report as submitted:

- Approximately \$200 from the budget is earmarked for kids' activities during the festivals.
- Planning for the Camp began in November 2019 and was slated to be at DE ÁNZA SPRINGS RESORT.
- Thank you to Gary Holden for working on the meal plan for the 2020 Kids' Camp.
- The camp for 2020 was ultimately cancelled due to travel restrictions.
- At the Spring Meeting, we learned that dÁS cancelled their offer to host the Camp.
- Kids' Camp was moved to OLIVE DELL RANCH and was very successful.
- Four children of AANR families attended. Two outside kids also attended, whose parents then joined AANR.
  - o Secretary's Note: A more thorough report is included in the meeting packet.



# **By-Laws and Procedure Manual** – Larry Gould stands by his report as submitted:

- Review of the ruling documents will take a while and ought not to be taken lightly. They need to also be reviewed by legal council to assure the necessary protection for this Region.
  - o **Secretary's Note**: No written report was submitted for the meeting packet.
  - **President's Note**: It is traditional to ask the Convention Delegates to approve or reject all the motions passed by the Board of Directors during the past twelve months ...
  - ❖ **POINT OF ORDER** by Cyndi Tendick: Credentials need to be reestablished before a vote since there may be a change in numbers since Day I's certification. Also, a motion with a maker and a second must be presented.
    - Secretary's Note: A list and copies of all approved motions from the 2020-2021 Session is delivered to the BL&PM chairman (a vote is never taken).

# **Scholarships** – Larry Gould stands by his report as submitted:

- This committee and subsequently the Board opted to present only one scholarship instead of the multiple ones as in previous years. The rationale being giving a few hundred dollars several recipients will not go far in today's schools, i.e., textbook costs. One award of the full \$1250 will have more meaning.
- Two applications were received. One was from a very good candidate but had no demonstrated connection to the nudist community. The other applicant is from MOUNTAIN AIR RANCH, has a 3.33 GPA from the Denver Public Schools and has been accepted to the University of Northern Colorado.
- Monies are not presented to the recipients but go directly to the school of his/her behalf.

## **Membership** – The following report was deferred from Day I:

- **Diversity & Inclusivity** Gary Mussell stands by his report as submitted:
  - O AANR already has a non-discriminatory statement in the By-Laws. The perceived difficulty is taking those words and making them a reality amongst the clubs. There is an underlying tradition that AANR leadership will not interfere with club operations but rather coach them when necessary. This has caused difficulty with some people who want to join but feel unwelcomed.
  - The Northwest Region put forth a statement to their clubs and asked them to sign onto it. It was then added to their website with a list of clubs which have affirmed (*aanr-nw.org/aanr-nw-welcomes-all*). The Florida Region is taking similar action. However, it is not a question of signing a statement; the question is, how are these promises kept in real life?

- O The PR committee for AANR is trying to tackle the on-going problem with cyber-trolling and bullying by writing guidelines for etiquette. False or misleading statements would be made against AANR or its members, corrections and facts would be offered but this just inflamed the instigators and their followers into writing more inflammatory comments. The guideline now is to ignore the statements, not to explain or correct, and to, "turn the other cheek." If, however, the attacks are from an account displaying or otherwise claiming AANR affiliation be it a club, business or individual then the regional officers or the Kissimmee office should be notified.
- Marijuana is another issue facing policy review. Some clubs are wanting to
  advertise themselves at cannabis dispensaries or on pot-related websites. In
  spite of possession and usage being still illegal at the federal level, a number
  of states have legalized or decriminalized marijuana for medicinal and/or
  - recreational use. The AANR policy is to empower clubs to decide for themselves based on their own culture along with the laws of their state or province.
- O The question of those feeling "unwelcomed" continues. New members, especially younger people, may not have concerns about marijuana, race, sexual orientation or other anxieties and many of the clubs are adjusting their culture to accommodate. The challenge is to break the paradigms, to shift attitudes, and to get people to sit down with someone new and get to know them.
- o The AANR PR committee also wants AANR to promote − on the website and in **The Bulletin** − those clubs which adhere to their guidelines and not highlight clubs that choose not to pledge. "If we can't tell you what to do, we can certainly, economically and promote the clubs that are doing positive." [sic]
  - Secretary's Note: Two questions for the Trustees at the AANR Convention: How is AANR justifying this report when two of its co-authors are primary instigators of the problems that AANR, AANR-West and members of this Region had on social media how are they explaining those two agitators being on this committee? As for the "guidelines" regarding blocking, the report states: While it may be tempting to block users for being generally annoying, be careful not to block users purely for these reasons: [sixth bullet point] They are a sex worker or adult film actor. What are sex workers and adult film actors bringing to the table of wholesome social nude recreation?

# **Conventions & Facilities** – Treena Saavedra stands by her report as submitted:

- A thank-you to SHANGRI LA RANCH for once again hosting our 2021 Convention; it has been great thus far.
   Our Fall Festival is at DE ÁNZA SPRINGS RESORT 8-10 October. LAGUNA DEL SOL will host the Fall 2021 Board of Directors meeting on the second Saturday in November.
- Bids for hosting the 2022 meetings, festivals and Convention are open and the new Board will vote on them in November.
