It has been a very busy four-month period since my last report.

Web Site:

The Web Committee (Walt, Ricc, and I) selected a web designer (Rocketboy Media, Inc, Chatsworth, CA) to build a new web site for AANR-West after interviewing several prospects. The designer we chose has his office near to all three of us, and has extensive experience building state-of-the-art sites for Chambers of Commerce and non-profit organizations. His ideas for combining calendars, donation requests, advertising, and basic information that can channel inquires to our clubs for follow-up is exactly what we were looking for. We have the capability to collect donations for GAT or other special causes, collect names from trade shows, etc. and do selective mass mailers directing these prospects to local clubs or future events. It is WordPress compatible. The price was in line with what others were asking. It is a 3-month job and it should be completed just in time to reveal itself at the summer convention. I have been meeting with the designer and his staff of writers about every ten days since we signed the contract to help with the implementation of our ideas. We will have a robust discussion about the move from Earth Village, no doubt, at the convention.

As we were going to press, we received an urgent email from Earth Village (see below) stating our existing aanrwest.com had been wiped out by some malware and they were going to have to rebuild it from scratch. So, we are moving away from Earth Village with all deliberate speed.

Subject: Web Site Update

I'm sure you've probably seen in the news about the latest NSA leaks of certain windows vulnerabilities and the latest WannaCry ransomware, this is something that is hitting systems hard as of late and is impacting millions of systems world wide. Our server systems are monitored 24/7 and we run the scheduled patches and updates sometimes as frequently as daily. But the malware that hit us this past week is the most virulent and destructive of anything any of our technicians have ever seen. Sadly, this type of Malware is very hard to detect and some form of zero day service is about the only thing that can be used to come close to fully protect against something of this nature. Staffing for that kind of 24/7 monitoring for each server is a physical and financial impossibility. Major corporations are having to deal with stuff exactly like this on a daily basis and there isn't much that can be done to stop it from happening 100% on all systems. There are so many different ways that the system could have been infected and even with everything decrypted there is no guarantee we will be able to find out how it occurred, or where the hacking breaches were coming from.

We were able to preserve all email correspondence, mailing lists, etc., on our email servers, but it is with real sadness that we must tell you the web site was too badly damaged to be salvaged. The web site will have to be designed new. We will certainly do anything we can to help, we have excellent designers on staff as you know, and we share with you the feeling of real loss! Let me know how you would like us to proceed. We're here to help you!

Meanwhile, Walt has directed Russell to retrieve all possible emails and other records and extract them to a safe place until the new web site is launched.

After we launch the basic site, we will begin work on the Members Only section, where people and club leaders can blog, where clubs can display downloadable brochures, promo photos and videos, members can run personal classified ads. Eventually we will have an on-line store where people can purchase logo merchandise such as hats and shirts from AANR-West and our clubs.

Marketing and Public Relations:

I worked the trade show booth at both the Bare Burro 5K Run and the Summer Festival. We collected names of people who wanted more information about AANR and our future activities. I am the designated Quartermaster for the region, so I managed the portioning out of giveaway items at each of the public events where we had our presence known. This included not only the travel and parks shows earlier in the year, and the two 5K runs in late spring, but also at the World Naked Bike Ride in Los Angeles, the monthly nude comedy shows that we co-sponsored, and the Hollywood Fringe Theater play that we underwrote. AANR-West was introduced to many hundreds of nudist-friendly people who did not know we existed. See separate inventory spreadsheet.

GAT:

As the region's Government Affairs Team (GAT) representative, I attended the monthly national conference call and discussed pending legislation and other community issues concerning nudity. See my separate report.

Legislation:

President Stephens asked me to review the current AANR-West By-Laws to suggest ways they could be modernized or at least made more efficient. Director Mike Glinzak heads that ad hoc committee along with Legislative Chair Tony Wilkinson. I was happy to contribute some ideas to them.

Nominations and Awards:

Another of my assigned duties is to recruit candidates who wish to run for the AANR-West Board of Directors and Board Officers. I am happy report we have more volunteers seeking office than we have open positions, so there will indeed be an election at the convention. The exception at the moment is Secretary. We have looked high and low but a volunteer has not stepped forward. We continue our search. Please see my separate report.

SECRETARY'S REPORT

Russell and I participated in the Olive Dell Bare Burro run. It well organized and fun. Russell and I helped in the AANR information booth and this went very well. I want to thank Mark Walters of SCNA for all of his help to set and breakdown the booth.

TREASURER'S REPORT

Treasurer, American Association for Nude Recreation, Western Region, Inc.

We finished the month of May 2017 with more than 96 thousand dollars in the main checking account, more than 800 dollars in the youth account, and more than 53 thousand dollars in the CD. We have almost 17 hundred dollars in other assets, and total assets of over 152 thousand dollars.

We have less than 8 thousand dollars in liabilities, and over 144 thousand dollars in equity.

So far this year we have income of over 17 thousand dollars, and expense of over 20 thousand dollars, so our net operating loss so far this year is over 27 hundred dollars.

I will be sending out the second quarter 2017 financial report some time during the first week of July.

INVENTORY





Legislation Report, Date: June 23, 2017

To: AANR West Clubs, Officers, Directors, and Members

From: Tony Wilkinson and Oliver B. Ellsworth

As of the date of this report, there are 14 propositions for consideration at the Regional Assembly. These items of legislation appear below.

All 14 propositions are amendments to the Association's bylaws. The maker of each is Board Member Mike Glinzak. The proposed changes were submitted in a single document. The most recent version of the document was received on June 19. The Legislation Committee has separated the proposed changes into 14 propositions to keep related changes together. The propositions may be considered separately or in combination.

None of the propositions has a significant fiscal impact.

Proposition #1—Amend Bylaws, Effective Pages / Art. IV(C) / Art. VIII / Art. X(C)

for consistency: General to Regional Assembly, Board of Directors in lower case
Amend as follows:

Article IV (REGIONAL ASSEMBLY) -- C. Delegates and Voting (page 5)

3. ... The instructions on the delegate forms may not be altered or controverted by the ~~general~~ regional assembly. If delegate forms are not received, the votes will neither be cast nor be delegated by the ~~general~~ regional assembly.

4. The AANR West regional associates shall meet at the annual convention prior to the opening of the ~~general~~ regional assembly to elect delegates. ...

Article VIII (OFFICERS CHART) (page 6)

OFFICE	PRESIDENT
Meeting and voting rights	Shall conduct all meetings of regional assembly and board of directors; shall not be a delegate in the General Assembly <u>regional assembly</u> nor vote in the General Assembly <u>regional assembly</u> except in case of a tie; shall have no vote in the B <u>board of D</u> directors' meeting except in case of tie.

Article X (FUNDS) -- C. Scholarship Fund (page 8)

... The Scholarship Fund shall be supervised by the ~~B~~ board of D ~~directors.~~ ...

Rationale:

(1) CORRECTION: Change 7 references to General Assembly (which is the AANR body) to regional assembly (which is the AANR West body), consistent with the rest of the bylaws.

(2) STYLE: Change 2 references to Board of Directors to lower case, consistent with the rest of the bylaws.

Proposition #2—Amend Bylaws, Article IV Regional Assembly (B) Time and Place

Amend as follows:

Article IV

REGIONAL ASSEMBLY

B. Time and Place

The regional meeting shall be held at the annual AANR West convention. The convention shall commence ~~on the Thursday two weeks during the four weeks prior to the AANR annual membership meeting, except when the AANR convention is held within the AANR West or AANR Northwest region. When the AANR convention is held in the AANR West or AANR Northwest region, the AANR West convention may commence on the Thursday one week prior to the AANR annual membership meeting.~~ The board of directors shall determine, if necessary, the precise date of the regional assembly.

Rationale:

Flexibility in scheduling the annual convention and its duration.

Proposition #3—Amend Bylaws, Article IV Regional Assembly (C) Delegates and Voting

Amend as follows:

Article IV, REGIONAL ASSEMBLY

C. Delegates and Voting

1. ~~All types of Delegates~~ to the regional assembly shall be ~~accredited~~~~delected~~ each year not more than 90 days prior to the opening prior to the opening session of the regional assembly.
2. The Club ~~accredited~~~~delected~~ delegates shall represent the clubs by apportionment of one vote for every 25 basic AANR West members of the respective club, or fraction thereof.
3. Should none of the accredited delegates of a club be able to attend, a club may delegate by proxy its right to vote at the regional assembly to ~~another~~~~an~~ accredited club delegation. However, no club delegation shall cast a combined total of more than 30 proxy votes in addition to the full number of its own votes, ~~except that a club which has a valid voting strength in excess of 30 shall be entitled to cast the full number of its own votes.~~ The instructions on the delegate forms may not be altered or controverted by the ~~general assembly~~regional assembly. If delegate forms are not received, the votes will neither be cast nor be delegated by the ~~general assembly~~regional assembly.
4. The AANR West regional associates shall meet at the annual convention prior to the opening of the ~~general assembly~~regional assembly to elect Associate delegates. ~~The Associate elected delegates shall represent the associates by apportionment of one vote for every 25 associate AANR West members, or fraction thereof, present. Votes shall be allocated in accordance with item two above.~~ Votes shall be carried only by a member of the regional associates, with each elected delegate carrying no more than one vote. No proxies to clubs or other delegates shall be permitted.

Rationale:

- (1) Consistency in use of the term accredited delegates. Club delegates are accredited through the credentials process. Associates gain accredited delegate(s) through an election prior to the opening of the assembly (for which reason the term elected remains in section 4). The amendment was made by the Legislation Committee in consultation with the Association's attorney.
- (2) Correct the term general assembly to regional assembly, to match the rest of document.
- (3) Introduce the term proxy. Clarify wording that larger clubs can vote up to 30 proxy votes.

Proposition #4—Amend Bylaws, Article IV Regional Assembly (C) (5): Quorum

Amend as follows:

Article IV

REGIONAL ASSEMBLY

C. Delegates and Voting

5. A quorum of the regional assembly shall consist of ~~two-thirds~~ a majority of the accredited delegates.

Rationale:

Protect ability to do business when a single large club is absent.

Proposition #5—Amend Bylaws, Article V Board of Directors (C) Meetings: Quorum

Amend as follows:

Article V

BOARD of DIRECTORS

C. Meetings

1. ~~Two-thirds~~ A majority of the members of the board shall constitute a quorum.

Rationale:

Protect ability to do business when directors are absent.

Proposition #6—Amend Bylaws, Article V Board of Directors (C) Meetings (2 through 5) Time & Date

Amend as follows:

Article V

BOARD of DIRECTORS

C. Meetings

2. The first board meeting shall be held ~~the day~~ within 24 hours following the adjournment of the regional assembly at which the new officers were elected.
3. The Fall board meeting shall be held on ~~the first~~ the first Saturday ~~each~~ in November after November 1.
4. The Spring board meeting shall be held on ~~the first~~ the first Saturday ~~each~~ in March not on Easter or Passover weekend.
5. The final meeting of the board shall be held ~~the evening immediately~~ within 36 hours preceding the opening of the annual regional assembly.

Rationale:

Greater flexibility in scheduling Board meetings.

Proposition #7—Amend Bylaws, Article V Board of Directors (C) Meetings (6 and 7) and (D) Interim Voting
Amend as follows:

Article V
BOARD of DIRECTORS

C. Meetings

6. ~~Special board meetings may be called in accordance with California law, by the president or by a two-thirds vote of the entire board. All officers, directors, trustees, and clubs shall be notified of the time and place of the meeting. Such notice shall be mailed at least ten days prior to the meeting.~~

7. Meetings of members may be held at a place within or outside this state. Members of the board may participate in a meeting through use of conference telephone, electronic video screen communication, or other communications equipment. Participation in a meeting through use of conference telephone pursuant to this subdivision constitutes presence in person at that meeting as long as all members participating in the meeting are able to hear one another. Participation in a meeting through use of electronic video screen communication or other communications equipment (other than conference telephone) pursuant to this subdivision constitutes presence in person at that meeting if all of the following apply:

(A) Each member participating in the meeting can communicate with all of the other members concurrently.

(B) Each member is provided the means of participating in all matters before the board, including, without limitation, the capacity to propose, or to interpose an objection to, a specific action to be taken by the corporation.

(C) The corporation adopts and implements some means of verifying both of the following:

(i) A person participating in the meeting is a director or other person entitled to participate in the board meeting.

(ii) All actions of, or votes by, the board are taken or cast only by the directors and not by persons who are not directors.

D. Interim Voting

Voting between board meetings shall be in accordance with AANR West interim voting procedures as established in the procedure manual when a Special Board meeting cannot be called.

Rationale:

Conform bylaws provisions for calling special meetings to California Corporations Code (Section 7211), and adopt verbatim (in item 7) provisions of the California Corporations Code regarding telephone, video, and web meetings. Retain existing Interim Voting procedure for use when a special meeting cannot be called.

Proposition #8—Amend Bylaws, Article VII Members (A(2), B, and D)
Amend as follows:

Article VII
MEMBERS

A. General

1. Membership shall be open to all as specified in the AANR bylaws.

2. The term "member in good standing" shall be defined as a person whose AANR and AANR West dues are currently paid in full, ~~and who is not on either the AANR caution list or bad credit list.~~

B. AANR West Regional Associates

Membership in the AANR West Regional Associates shall conform to AANR bylaws ~~Article VI.D.2~~ and the AANR Governance Manual.

~~Section II.~~

C. Membership Suspension

A local club may suspend or expel a member for good cause in accordance with established club procedures. No member shall be expelled from AANR West without the opportunity of a hearing, and he must be furnished a copy of all charges against him at least five days prior to such hearing.

D. Membership Dues

Dues shall be established by the regional assembly, ~~as outlined in Section 8.00.00 of the AANR West procedure manual.~~

Rationale:

- (1) Remove an obsolete reference to external lists of potentially negative personal information which could cause liability to the Association.
- (2) Remove specific references to numeric sections of AANR documents that might invalidate the reference if the numbering was changed by AANR.

Proposition #9—Amend Bylaws, Article VIII Officers Chart, Vice President

Amend as follows:

Article VIII

OFFICERS CHART

OFFICE

Preparation & signing of AANR West documents

PRESIDENT

Shall sign all official AANR West documents as directed by the board; may countersign checks.

VICE-PRESIDENT

None except when properly presiding in place of president; may countersign checks with the approval of the president.

Rationale:

Bank practice is that the Vice President is a signer on the signature form. Change matches bank practice if the Association President gives approval.

Proposition #10—Amend Bylaws, Article IX AANR Trustees (A and B)

Amend as follows:

Article IX

AANR TRUSTEES

A. One AANR West member ~~trustee~~ shall serve as the AANR West representative (AANR West Trustee) to AANR in accordance with the AANR bylaws, ~~Articles V and IX and the~~ Officials' Qualifications Chart and ~~with the~~ AANR Governance Manual ~~3.02.04~~.

B. ~~The AANR West President shall be the~~The alternate AANR Westmember trustee ~~shall be the regional president per Article IX of the AANR Bylaws.~~

Rationale:

- (1) Clarifying wording suggested by legal counsel (the member is a representative and thus becomes an AANR trustee)
- (2) Remove specific references to numeric sections of AANR documents that might invalidate the reference if the numbering was changed by AANR.

Proposition #11—Amend Bylaws, Article X Funds, (B) Legal Fund

Amend as follows:

Article X

FUNDS

A. General Fund

This operating fund of AANR West shall be paid all income not otherwise directed.

B. Legal Fund

This fund shall be comprised of funds donated to AANR West specifically used to retain legal counsel when desired, necessary and to defend the constitutional right to practice nudism. The fund shall be supervised by the ~~Board of~~ Board of Directors. In an emergency, an expenditure not to exceed \$1,000.00 may be authorized by a majority of the officers. Nothing prevents the Board of Directors from also making expenditures for this purpose from the General Fund, the Legal Committee. Any reimbursement for legal fees paid from this fund and awarded to AANR West as a result of litigation shall be deposited back to this fund.

Rationale:

- (1) Remove reference to a supposed constitutional right to practice nudism that is not supported by case law, and which unnecessarily restricts the use of funds.
- (2) Transfer authority over the use of the fund from a loosely defined legal committee to the Board of Directors (here required to be capitalized to be specific).
- (3) Specify that money used from this fund be repaid to it if there are awards to AANR West as a result of the supported litigation.

Proposition #12—Amend Bylaws, Article X Funds, (C) Scholarship Fund

Amend as follows:

Article X
FUNDS

C. Scholarship Fund

This fund shall be ~~comprised of funds donated to AANR West specifically used to award scholarships to children of AANR West members under the age of 27 parents~~ for their higher education. The Scholarship Fund shall be supervised by the Board of Directors. ~~Scholarship awards shall be authorized by the Scholarship Program Committee.~~ Nothing prevents the Board of Directors from making expenditures for this purpose from the General Fund subject to the annual budget review process.

Rationale:

Except for exclusively donated funds, scholarship funding becomes a line item in the General Fund which allows for budget flexibility. Age 27 is specified in the Procedure Manual.

Proposition #13—Amend Bylaws, Article XI Parliamentary Authority

Amend as follows:

Article XI
PARLIAMENTARY AUTHORITY

The most current version of Robert's Rules of Order shall govern AANR West's parliamentary procedures provided that Robert's will be overruled to the extent it is inconsistent with any AANR West ruling document(s). For parliamentary procedures, any AANR West ruling document(s) will be overruled by the AANR ruling documents to the extent of any inconsistency, unless they are inconsistent with the AANR West or AANR ruling documents.

Rationale:

Establishes a hierarchy of ruling documents for parliamentary procedures. Reference to parliamentary procedures inserted by the Legislation Committee on the advice of Counsel.

Proposition #14—Amend Bylaws, Article XII Amendments to Bylaws (A(2), B and C)

Amend as follows:

Article XII
AMENDMENTS to BYLAWS

A. Automatic Amendments

1. If AANR revises any portion of its bylaws, such revisions shall automatically, although not necessarily verbatim, become part of the AANR West bylaws, effective at the same time as the AANR revisions.

2. The legislation committee may correct spelling, punctuation, abbreviation, capitalization, numbering and grammar of the ruling documents, to conform to current usage. No such corrections may alter the meaning or application of any document.

All corrections shall be subject to ~~rejection~~ review by the ~~Board of Directors~~ no later than 90 days after such change(s) has been approved by the legislation committee.

B. Proposed Amendments

Except as specified in Section A above, the AANR West Articles of Incorporation and the AANR West bylaws may be amended only by the regional assembly of AANR West by two-thirds ~~of the votes held by vote of~~ the accredited delegates present. The legislation committee must receive amendments proposed by members no later than 60 days prior to the regional assembly. The legislation chairman may reword or revise such proposed amendments for clarity. A copy of such change, along with any other similar amendments, shall be mailed to the maker of the amendment. No later than 45 days prior to the regional assembly, the legislation chairman shall forward all proposed amendments to the recording secretary. No later than 30 days prior to the regional assembly, the secretary shall mail a copy of all proposed amendments to each AANR West officer, director, AANR West trustee and club. The legislation committee shall present proposed amendments to the regional assembly.

C. Policies and Procedures

As its sole governing documents, the Articles of Incorporation, the AANR West bylaws, and the procedure manual of AANR West shall hereafter determine all policies and procedures of that body. In case of a conflict, the provisions of the AANR West bylaws shall prevail.

Rationale:

- (1) In section B, clarifies the vote needed for amendments. If Proposition #4 is approved, the quorum for the Regional Assembly is half of the accredited delegates. This revised wording maintains the requirement for 2/3 of the votes that those delegates hold.
- (2) The other additions clarify that the references regarding AANR West amendments refer to AANR West documents and (for notice) the AANR West trustees and clubs.

This completes the Legislation Report.
A summary of Board Actions taken during 2016-2017 will be provided at a later time.

Government Affairs Report – June 23, 2017

The Government Affairs Committee consists of Gary Mussell and Mike Glinzak. It is a task we must do each morning so that no proposed legislation or court case that affects nude recreation slips by. Mike has decided to leave this committee to focus on other areas of interest in AANR-West. Gary will continue in this role until a successor can be found and trained.

Here are the highlights from these past four months.

San Francisco Ban on Public Nudity Ruled Constitutional by Ninth Circuit

If there was any doubt before, nudity is not a first amendment right, according to both the US Supreme Court (*Erie vs Paps*, and *Barnes vs Indiana*, etc.) and the Ninth Circuit Court of Appeal. Local governments such as states counties, and cities are free to regulate it.

On May 25, 2017, the Ninth Circuit Court of Appeals rejected a challenge to San Francisco's controversial law banning public nudity. The two plaintiffs seeking to overturn the law, Oxane "Gypsy" Taub, and George Davis, both faced prosecution under the law after donning nothing at all at the city's eccentric Bay to Breakers cross-city marathon and deliberately straying off the course, and at a local street fair in the city's foregone hippy epicenter, the Haight-Ashbury neighborhood.

Among San Francisco's many claims to fame, the casual attitude toward nudity is one that has fallen out of fashion, due much to the antics of Gypsy and George who have rallied a small group of supporters to appear nude at various public places around the city including public buses and at the tourist-centric Fishman's Wharf. In 2012, the city passed an ordinance requiring any person engaging in a public display of nudity to have obtained a parade permit first. In what is sure to be an upset to nudists everywhere, the ban has been ruled constitutional.

Even worse, the court explained that **the First Amendment does not provide absolute protection for all forms of expression. It reasoned that the city had a compelling enough reason to institute the ban, and that the ban does not prevent the expression of the idea of nudity, but merely the conduct used to express the idea.**

Content neutral restrictions are speech that are frequently upheld as constitutional. Additionally, the court found that the permit requirements were not overly broad, and the challenge to the permitting process was also rejected.

Gypsy and her group continue to hold protest rallies against the law and the court decision.

American River Canyon

On May 23, we were informed the California State Parks and the US Bureau of Reclamation are collaborating on preparation of a General Plan/Resource Management Plan for Auburn State Recreation Area, and federal lands set aside for the potential construction of Auburn Dam and Reservoir. The plan will define a long-term vision for the 30,000-acre park unit, provide guidelines and direction for the management of natural and cultural resources, determine management of recreation activities which may occur there, and identify potential facility improvements. A joint Environmental Impact Report/Environmental Impact Statement will be prepared as part of this project, to describe potential environmental effects of plan implementation.

Just below the Auburn Dam, on the north fork of the American River, is a very popular destination for nudists in this part of California.

The first public workshop on this planning process was held on November 12, 2015, in Auburn. A proposal to eliminate nude recreation in the area was beaten down by a room full of speakers at the public hearing.

California State Parks and the US Bureau of Reclamation have not given up, and are scheduling a new round of hearings "in late 2017." We are working with the local River Dippers nudist club to prepare now for the new hearings in case they are trying to create the ban again. We plan to send speakers to the hearings also, whenever they are held.

California Parks Forward

There was another meeting of the California Parks Forward Commission in May. This was the group created by the state legislature several years ago to rethink the entire state park system and find our sources of funding for them besides the government. We were asked to submit a proposal to include clothing optional beaches and hiking trails into their proposal but in the end, they kicked it back to the California Department of Parks and Recreation to solve the need (as well as the desire for more bike trails and how to designate parks where dogs off leash are allowed).

This meeting reviewed the progress made by the legislature on enacting their recommendations, which have been few and far between because of budget priorities.

A year ago, we testified at a public meeting of the State Parks Commission about the need for nude recreation in the state and of our submitted report. They directed the Parks Department to meet with us to talk about how to do this, but no meeting has ever taken place. And there has been no meeting of the Parks Commission since, either.

World Naked Bike Ride - Los Angeles

The second Saturday each June, as many as 400 people in Los Angeles remove their clothes to go “As Bare As You Dare” and ride *en masse* through the heart of the city on its main streets for a couple of hours.

At first reading that may sound crazy or inappropriate, but the annual event, which began in Germany in 2003, has expanded to over 200 cities worldwide in the past decade. The purpose is to protest the lack of bike lanes and safety programs, to ask people to use their automobiles a little less, and to promote body acceptance. Most participants use bicycles, but some are on skateboards or inline skates. And it is great fun! Most of the riders were under age 30.

AANR-West is a co-sponsor and financial backer of this annual event, along with SCNA and other local nudist groups. We had an information table and handed out AANR literature and some giveaway items like lip balm and pens.

The Los Angeles ride began about 10 years ago with great difficulty because of the city’s strict anti-nudity and indecent exposure laws. But we worked with the city council and found a flaw in the ordinance: nudity is prohibited at Los Angeles beaches and parks, but they forgot to include streets. If we ride on public streets and remain in designated bike lanes, the city attorney agreed to not issue citations since our “protest” falls under First Amendment protection.

For the past several years, we have gathered at a secluded area downtown. There is a bodypainting booth for those who want to decorate themselves with color or a painted sign on their backs. There are also signs to attach to each bicycle. We have a food truck and portable toilets, and some people bring guitars or other musical instruments. It resembles a large naked street fair. The event also attracts news media, so we have designated people to speak our talking points to get our body-positive message out. We often get 30 seconds on the local evening news, images pixilated of course.

The LA ride took about 3 hours to complete and is broken into two parts: a shorter 5-mile course for those who are out of shape and a longer 16-mile route that snakes through Chinatown, past Dodger Stadium, around Silverlake, past city hall and the main police station, then back through downtown to the starting point. For those who get too tired to continue we have two pickup trucks and two follow cars to pick up stragglers.

Along the route most people wave and take pictures with their cell phones. Every year one or two people flash their breasts or drop their pants in solidarity.

For the past three years we have had a police escort, which tells you how far we have come in official and public acceptance.

California Megan’s Law.

Many local nudist clubs use this list when reviewing park guests or potential new members.

California AB 558 expands the Meghan’s Law list to include people who were convicted of misdemeanor child molestation (not just a felony) or who were harassed via the Internet. Harassment can include the sending of naked images to the victim, or demanding the same from the victim. What defines a naked image seen by the victim, or a personal photo sent by the harasser, or perhaps sending a photo of a nudist park or beach? We understand what the author wants to do but her definitions are too vague. The bill passed the Assembly on May 31 and is now in the Assembly Public Safety Committee. No hearing date has been set.

Wyoming

Wyoming HB 298 prohibits minors from sending or receiving nude photos, but it is so broad that we interpret the bill as making anyone who receives or forwards an *AANR Bulletin* or *N Magazine*, or photos of a nudist park or beach, could be guilty of a felony.

The bill passed essentially unanimously through both houses of the legislature within five weeks, which is an astounding speed, and it was signed into law by the state governor. There was no time to protest or even send a letter asking for better definitions. This will have to be adjudicated in the courts down the road and we will watch for when that happens to see if we want to file an amicus brief. AANR should start preparing now.

Hawaii

The 2000 Hawaii Supreme Court decision *State v. Kalama* ruled that law enforcement agencies cannot arrest or issue a citation to a person who is nude unless a the person is acting in a lewd manner.

SB691 would have expanded the authority to arrest or cite if a person “exposes the person's genitals within reasonable proximity to another person that it might cause affront to that person.” This includes simple nude sunbathing.

We were concerned as this could be interpreted as a total ban on nude recreation within the entire state. We were prepared to work with NAC and jointly hire a lobbyist if necessary. Fortunately the bill never had a hearing as the committee chair where it was assigned was opposed.

New Mexico

HB 43 redefines sexual offenses and expands the scope of sexual contact to a minor. Among other things, it adds “mental anguish” that requires psychological or psychiatric treatment by the victim if they feel threatened by sexual contact or potential sexual contact. The bill, as passed 66-0 by the state House, is so broad it could define reading a naturist magazine or going to a nude hot spring with their parents as potentially traumatic to the child. We will watch to see if the State Senate tightens up these definitions or not. According to the CQ Tracking online legislative software we use, its hearing in the Senate Judiciary Committee has not yet been scheduled.

Other issues (not in the Western Region) being discussed by the GAT Committee at its monthly regional phone conference:

The new Federal Wilderness Area Federal Budget

The Trump Administration is starting to propose a rollback in federal regulations and budgetary allocations to agencies responsible for supervision of federal lands. The White House is seeking only about \$100 million in funding for capital improvement and maintenance by the National Forest Service, down from \$363 million this year. That 73% cut could have a huge impact on recreation in general and nudist recreation on public lands specifically because it likely will result in the selling off public lands to the states and to corporate interests for development, according to Rebecca Turner, senior director of programs and policy for American Forests, a nonprofit conservation organization.

GAT and the AANR office are discussing putting out an email to all members suggesting members contact their Congressional representative to tell them they oppose the cuts proposed. No decision has been made on this as of this writing.

The **Utah** legislature passed a resolution this year endorsing the idea of selling off public land for development purposes. The legislature has many proponents of the “open range” movement where some local radicalized ranchers do not want to pay BLM grazing fees for their cattle.

Top Freedom at Ocean City, Maryland

Chelsea Covington has been an advocate for “Top free Equality” with men for several years. Her position is that, almost a century after women won the right to vote, nudist organizations should help support her effort to let women take their tops off anywhere that men can, to if they choose.

The story made national news after Chelsea and some friends started going top free along the beachfront at Ocean City, Maryland. As one reported wrote in the *Washington Post*, “This family-friendly place with “No Profanity” signs along the boardwalk, guys selling Bongzilla outside its boardwalk shops; T-shirts stores with sex jokes printed on the front, and a Hooters restaurant. Also: twerking, thongs and foam dance parties galore. But please, save the children from breasts...Welcome to America, land of mixed messages and double standards.”

Maryland law is not entirely clear when it comes to the question of whether women are expressly prohibited from baring their breasts in public. So, the beach patrol told lifeguards not to confront bare-chested women or ask them to cover up while the issue was sorted out. Unfortunately, that order rippled through social media that proclaimed that “Ocean City is topless!”

On Saturday, June 10, the Ocean City Council convened an emergency meeting to pass a public nudity ban. The ordinance makes public nudity a municipal infraction punishable by a fine of \$1,000 and once again enforceable by the local beach patrol. The quick action took everyone by surprise, and we could not respond in time with a response. However, we expect a court challenge to the ordinance so there may be an opportunity for AANR to respond at that time.

Special Election: Montana

In mid-May, it was brought to our attention that the Democratic candidate for Congress in the special election in Montana last month was Rob Quest, a frequent entertainer at the Sun Meadow nudist park near Coeur d’Alene. The Republican candidate made the nudism part of his “family values” campaign against his opponent. The AANR office along with other naturist groups decided this was an opportunity to respond to the media about the positive effects of social nudism. Quest lost this election in early June.

Idaho BLM Proposed Supplementary Rules Issue.

The Bureau of Land Management (BLM) proposed changes to its Statewide Supplementary Rules in Idaho in 2015. The full document can be found online at: <https://www.federalregister.gov/documents/2015/02/03/2015-02068/proposed-idaho-statewide-supplementary-rules>.

Due date for comments to be received was 04/06/2015. AANR learned about this proposal on May 31, 2017, from a BLM employee who was thoughtful enough to bring it to our attention during the Partners Outdoors meeting in Washington, DC.

Pertinent Extracts from the Document:

- “Public nudity: The BLM recognizes that some individuals and groups desire clothing-optional recreation. However, in areas where recreational opportunities and/or facilities draw large numbers of visitors, public nudity can create controversy and conflicts among users, and cause law enforcement concerns. The intent of the proposed supplementary rule is to prohibit public nudity at all developed sites, hot springs, and other high visitation areas. This would still allow lands with a lower concentration of visitors, such as wilderness areas, to be clothing-optional.”
- Definitions: “Developed recreational area or site means any site or area that contains structures or capital improvement primarily used by the public for recreational purposes. Such areas or sites include delineated spaces or areas for parking, camping or boat launching; sanitation facilities; potable water; grills or fire rings; tables; or controlled access.”
- Public nudity means nudity in an open place.
- “Public nudity is prohibited in all developed recreation areas or sites, visitor centers, hot springs and other high visitation areas located on public lands.”

After a phone conversation among the GAT representatives it was decided to submit the following letter to the BLM Idaho Office:

Dear Mr. McGrath, In February of 2015, the Bureau of Land Management published in the Federal Register a document entitled “Proposed Idaho Statewide Supplementary Rules.” Among other things, the proposed rules would ban public nudity in developed areas of BLM lands in Idaho. We were unaware of the proposed rules until we were informed last week, so did not submit comments on them by the stated due date. Nevertheless, we have a few suggestions to make and hope that you will consider them as a way to improve public understanding and compliance with the proposed rules. You can appreciate that we become very concerned whenever rules limiting nude recreation are proposed. That is why we paid attention to your proposed rules when we did hear about them. Nevertheless, having read and discussed the text in the Federal Register, we have concluded that overall your proposals make sense. We appreciate your desire to minimize controversy and conflicts among visitors and between visitors and law enforcement personnel. Even though we hope someday that nudity or at least clothing optional recreation will be allowed, if not common, in many recreation venues on our public lands, we recognize that we must be content with reasonable regulations in the meantime.

On the other hand, we also recognize that the best interests of our members and of the general public are furthered only when those regulations are clearly written so they can be easily followed. Rules such as those you are promulgating should be as clear as possible so that visitors can know what is allowed and not allowed without having to learn them through an encounter with a law enforcement officer. While the proposed rules generally are well written, there are a few phrases that we believe are ambiguous enough to cause confusion. For example, in the paragraph headed “Public nudity,” you state that nudity is banned in areas that “draw large numbers of visitors” and in areas of “high visitation.” Those restrictions seem sensible but the terms “large” and “high” are imprecise. How many visitors must be present before some unstated threshold is reached?

Also, do crowds have to actually be present for that threshold to be met or is it necessary only that the site can have heavy visitation? Your language leaves it up to the visitor to decide if it is OK to be nude in a campground that is empty of other visitors or if s/he has to get dressed because two people show up at a site that has had no visitors for some hours or days. For visitors to have to make such decisions on their own is unfair and can create unnecessary problems for law enforcement. Another example: You state that nudity will be allowed in areas of "low concentrations" of visitors and in wilderness areas.

You also state that nudity will not be allowed in hot springs. If someone wanted to be nude in a hot spring located in a wilderness area, would that be allowed? Again, the statements are contradictory and should be clarified.

Your definition of "public nudity" also is ambiguous. It is defined as nudity in an open space. But what does "open" mean. If nudity is allowed in wilderness areas, does the nudist have to stay in the trees or can s/he be nude in a high mountain meadow, clearly an "open" area? If you intend to prohibit someone from being nude in a place where s/he would be openly visible to other people (presumably crowds of people and not just "low concentrations"), then the definition should be revised accordingly. Finally, we are concerned about the definition of "developed recreation areas."

Clearly any recreation site that contains buildings, camping pads, sanitation facilities, and other such capital improvements rightly can be considered "developed." However, we have to wonder if that definition is intended to cover minimal or primitive features that the average visitor would not necessarily recognize as structures or typical capital improvements but that obviously have been constructed by man (as opposed to naturally occurring).

For example, would trails constructed and maintained by BLM or the presence of such features as steps, handrails, or other constructions intended to guide users or to provide safety qualify that site as "developed?" We believe that your definition needs to be clarified to eliminate confusion in the mind of the visitor who wonders whether or not a sign or rail fence along a steep trail side puts him in a "developed" area. Before closing, let me say that we do very much appreciate your acknowledging the appropriateness of allowing nudity in wilderness area and other places where there are few if any other visitors. That is a very realistic position to take and we applaud you for it.

REPORT

I have been quite busy working with the Legislation Committee regarding the latest round of proposed By-Law changes. A lot of good work has been done by all involved and the proposed changes certainly move the AANR West By-Law further along and help clarify multiple sections. I look forward to further efforts in this regard and stand ready to assist as needed.

Recently the Federal 9th Circuit Court of Appeals decided the case of "Gypsy" Taub who was arrested in San Francisco for public nudity. This court ruled that there could be compelling government reasons to institute nudity bans. While this case is not helpful it is not the end of the legal story. Many nudity events could still be valid and protected under the 1st amendment's right of free speech. However specific facts (where, timing, why, the purpose of the event, etc) are still important. This makes consulting legal counsel even more important than ever if you are planning any such events. Attached is the actual case for further reading.

I have been working with Walt Stevens in regards to ways AANR West can coordinate and share information with the national AANR organization to better serve AANR West members. In this effort, we are also in discussions with multiple officials at AANR on such things as website access and cross promotion.

There has also been some legal issue with the AANR West website hosted by Earth Village which I have been assisting with but due to the confidential nature of those items, no details can be provided at this time.

Finally, I want to thank all the board members and officers of AANR West of the opportunity to serve as legal counsel. You are a great group of folks who truly care about AANR West and all of its members.

This small black sand beach was briefly in the national spotlight last year as this Board prepared to meet in California. On the morning of 1st November, Mountain View resident Paul O'Leary was making good time on one of his regular swims at Kehena when he suddenly felt like he had caught his right foot on something under the water. It wasn't until the 54-year-old got out of the murky water that he learned he had become another statistic in an unusually grisly year for shark attacks in Hawai'i. O'Leary was brought to shore and rushed to hospital where he received more than fifty sutures to close a gash on his ankle and repairs to two torn tendons.



O'Leary was being interviewed by a group of journalists when he was quoted as saying, "If you've never gone swimming nude, you *gotta* try it. You feel very free ... there's very little resistance." His doctors expect him to make a full recovery after some physical therapy.

AANR-West salutes Paul O'Leary for his bravery, his sense of humour through this ordeal and his positive endorsement for enjoying the surf naturally. As for those morning swims, O'Leary says he expects they will continue as soon as allowed, albeit not on days when the water is murky.

Club Liaison Report – June 23, 2017

Bates Beach, Carpinteria, California

We are happy to report that after many years of community and political involvement, the western section of North Rincon Beach has finally been allowed to return to its traditional clothing-optional status in Santa Barbara, California.

The Friends of Bates Beach, a division of the Southern California Naturist Association (SCNA), started work on this in earnest about 2007 after the beach was swept clear of nudists in 1999 and 2000 despite a 40-year tradition of “live and let live” nudity there. The northern half of Rincon Beach, at the boundary of Santa Barbara and Ventura Counties, was always referred to as Bates Beach, named after the freeway exit road that took people to the beach. All that changed when local homeowners complained, and the sheriff deputies swept the beach issuing tickets to finally drive the nudists away.

The county hoped that the textiled beachgoers would drift up the beach and replace the nudists there, but they didn't. Instead local gangs came in and sprayed graffiti on the walls, and drug dealers took advantage of the lack of people to do their drug sales there. After five years the nudists had had enough and approached SCNA to help get the beach back. The club, centered in Los Angeles and Ventura Counties, created a new fictional business name for itself in Santa Barbara County: Friends of Bates Beach (FOBB). They budgeted over \$1500 to the cause each year, joined the local **Chamber of Commerce**, and became active in local community events. Each year, FOBB coordinated the annual California **Beach Cleanup Day** each September, attracting dozens of local volunteers to clean up the trash at the beach and other nearby creeks. The publicity was very positive.

FOBB demonstrated the purchasing power of nudists by paying for everything with **\$2 bills**. After a few years this marketing gimmick became well-known all over town as people realized how many nudists lived in the Carpinteria beach town. FOBB also became active in local politics and supported several friendly candidates for city council., the state legislature, and for county candidates.

We also created a **Beach Ambassador** program at Bates. Based on the successful program at Haulover and Gunnison beaches, we trained volunteers to be a “neighborhood watch” to reduce drug and gang activity in the area and to prevent any inappropriate behavior on the sand. All we asked in return was an amendment to the county anti-nudity ordinance allowing a legal nude beach at Bates. This campaign took a lot of time, work, patience, and money. But we persevered.

Finally, because of all of our community activism, we convinced the County Supervisor in the south county that nudists deserved to have their beach back. But he wasn't interested in formally changing the law, as that was still politically a step too far. Instead he contacted the County Sheriff's department and the County Parks Department and convinced them to agree they would no longer issue tickets for simple nudity at Bates unless there was a complaint for lewd conduct or something more serious than just minding our own nudist business. This is the same arrangement that exists at many other nude beaches around the country. We accepted.

Our first major beach party was June 17 and it was very successful. About 30 nudists showed up for the first time in 17 years to test the waters and the reaction of other beachgoers. We were pleasantly surprised to receive a warm greeting. Some, upon seeing us ditch our clothes, decided to join in the naked experience also. Over the coming year, as word spreads that we have the beach back, we expect that number to grow to about a hundred on weekend days. Volleyball games and BBQs are already being planned.

AANR-West was very helpful for the past dozen year, contributing badly needed money to the cause. Several of the nudists at that first beach party were AANR members who lived locally. The Naturist Action Committee, associated with the Naturist Society, gave lots of legal advice over the years. Last, we need to thank both Shirley and Richard Mason of Haulover Beach, who were pioneers at reclaiming a piece of Florida beach for nude use. Their advice and mentoring over the years was always helpful.

In summary, this was a **group effort** with many organizations working together to bring us success. But the courageous nudists in Santa Barbara never lost hope, and their “feet in the sand” on the beach and staffing information booths, and working the crowds in community parades are what got us the eventual victory.

Pirate’s Cove, Avila Beach, San Luis Obispo

Leaders of the Whales Cave Conservancy (WCC) remain frustrated with the San Luis Obispo County Parks Department. Despite the Coastal Commission decision to keep the beach area undeveloped, the parks department continues to push for new park development to increase tourism in the area.

Meanwhile the parking situation is becoming worse with “a constant stream of cars driving up, finding no parking and leaving or parking illegally.” On March 11, WCC counted 164 cars parked above the beach and on adjoining Cave Landing Road despite No Parking signs placed there by the county. WCC fears the sheriff may focus on parking violations once summer approaches as a way on reducing nude use at the beach.

Overall the beach saw fewer night parties than the year before. Sheriff and Harbor patrols have come down on several occasions and that has helped. College students still party at one end of the beach, leave behind beer bottles and trash that WCC must haul up the cliff to the parking lot, where it sits for days waiting for pick up by the county.

On Cinco de Mayo weekend, the club led an organized beach cleanup. Another will be held after July 4 weekend, and yet another on the September 16 California Beach Cleanup day.

AANR-West has assured the WCC we are available to help if called. I said I was personally happy to drive up to speak to anyone if that is necessary.

The Olympian Club

The Olympian Club enjoyed a four-day weekend at DeAnza over Memorial Day Weekend, where they celebrated their 64th Anniversary. June featured a Brunch/Bingo Day with the club providing a full breakfast, followed by a round of Bingo with cash prizes. Everyone enjoyed the pool and hot tub. To top off the day, they had an Ice Cream Sundae bar with all the toppings.

July’s big event will be an 8th of July pool party with free hot dogs and a Chili Cook-Off. In August, the club will host their annual free picnic/pool party with hamburgers, hot dogs and all the fixings. They’ll finish off the Summer Season in September with their last home pool party, and finally a day trip to Olive Dell.

The club is attempting to bolster participation by offering more new events and more outdoor activities. Their current calendar includes monthly house parties, trips to landed clubs, and special outings. Membership dues are only \$35 per single and \$55 per couple.
