  - Attempting to work with OLIVE DELL RANCH for a favorable resolve but being met with lots of resistance.
- The lawsuit which hovered profoundly over the Region this past year has been settled.

**Vice President** – Treena Saavedra stands by her report as written:

- This has been a stressful twelve months but there have been positive outcomes as well.
- Was able to recruit new members on the Big Nude Boat cruise this past February.
- There are five open seats on the Board of Directors. Nominations are still open for candidates.
- The four officers’ seats will be open next Assembly, so please consider viable candidates for those positions.

**Secretary** – Andy Walden stands by his report as written:

- As direct AANR memberships increase, a balance between club and individual needs warrants attention.
  - One idea is to bring smaller non-landed clubs together in a sort of *co-op* of memberships and facilities.
  - Clubs could coordinate activities and gathering locations to benefit members in the vicinity.
- In appreciation for the work by this current Board and looking forward to continued success this coming year.

**Treasurer** – David Ziegler stands by his report as written:

- In has been a quiet year. The goal was to break even but the Region actually gained substantially in net assets.
- Spending money is no worry as long as it benefits AANR or helps promote nude recreation in general.
- The monies received from AANR is directly proportional to our regional membership.
- Expenses include travel, insurances, website, Internet services, tchotchkes and promotional items, stipends, &c.

**Trustee** – Kathy Watzel stands by her report as written:

- This year’s National Conference of State Legislatures was in Louisville, Kentucky.
- The AANR Convention begins right after the AANR West Convention concludes.
- It is a slow process reverting from Impexium™ back to Connetics™ for our data base.

**Public Relations** – Each sub-committee reports individually:

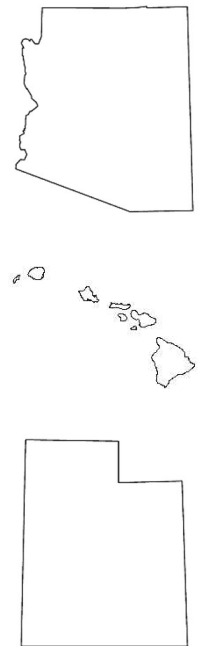
- **Social Media** – Gary Holden stands by his report as submitted:

- **Website** – Tom Stark stands by his report as submitted:
  - Advertising on the website continues to move forward. A committee is needed to field applicants.
  - Over 24,000 users have visited the website in the past year. On average, engagement is 02M01S.
- **'Blogs** – Gary Holden stands by his report as submitted:
  - Articles covering a wide range of Nudism-related themes (e.g.: legal framework, health advantages, societal perceptions, activities associated with Nudist culture) are available via the website.
- **Newsletter** – Gary Holden stands by his report as submitted:
  - March 2023 had the highest number of hits for **The Western ☀️ Sun** in the past two years. Factors contributing to this spike in hits will be examined and potentially replicated in future editions.

**Membership** – Cyndi Tendick presents a verbal report:

- The AANR Membership/Marketing committee is focusing on *connection generation* events.
- Looking at creating unity events for inter-club activities to help bolster attendance and interest.

**Club Relations** – Each club liaison reports individually:

- **Arizona Clubs** – Fredericka Carlile stands by her report as submitted:
  - **GOLDEN VALLEY SUN CLUB** – Their first event was on 27<sup>th</sup> July. Guests included the Tendicks and friends from DE ANZA SPRINGS. Click [goldenvalleysunclub.com](http://goldenvalleysunclub.com) for info.
  - **Hillside Sun Club** – This independent group is based in Bullhead City and is working in conjunction with GVSC to bolster their memberships in the CA/NV/AZ tri-state area.
- **Arizona Resorts** – Andy Walden stands by his report as submitted:
  - **MIRA VISTA RESORT** – Located northwest of Tucson, this premier property with a storied history before becoming the beautiful nude resort we know today.
  - **SHANGRI LA RANCH** – Nude Recreation Week began with everyone getting dressed! The annual Swim Camp offers certified instructors to teach basic skills to local kids.

  - **SWIM FREE HAWAII** – Capt. Chuck schedules one trip daily. He is licensed, insured and equipped for up to six passengers. Explore coral reefs and tropical fish — nude!

  - **Friends of Little Beach** – The status of Little Mākena remains *iffy*. DLNR officers occasionally patrol the cove, and the bills aimed at curbing nudity failed to gain ground.

  - **SOUTHERN UTAH NATURIST SOCIETY** – Temperatures are reaching over 100°, so the pool is the place to be. Membership has grown and attendance has now doubled in size.

The foundation is a 501(c)(3) charitable organization in partnership with, yet independent from, the AANR operations. **Executive Director** – Erich Schuttauf presents a verbal report:

- Just arriving from the National Conference of State Legislatures was in Louisville, Kentucky. In addition to legislators from across the nation, the conference draws lawmakers and their staff from many of the Canadian provinces and readings as well. Joe Rivas, President of AANR Florida is originally from Puerto Rico and was at the AANR booth speaking to commonwealth representatives about pending bills.
- For those following in [The Bulletin](#), two concerns facing Nudism in a number of states and provinces are: nudity in public and nude activities where children are present. Hawai‘i and Wisconsin, for example, propose changing verbiage from *indecent exposure* to *intentional exposure*, a subtle yet significant difference. “Indecent” requires something that arouses or offends, whereas “intentional” changes the standard for conviction.
- The Florida State Legislature has specifically recognized the American Association for Nude Recreation by name, and any of its chartered clubs, resorts or businesses operating within the state are exempt from certain regulations pertaining to massage therapists. AANR is not seeking exemptions, but rather official recognition as legitimate entities, which is important when dealing with lawsuits where Nudism is used against us.
- The Province of Ontario has recently had similar debates over public nudity or where children are present. At NCSL, the pins AANR hands out are more than a collector’s item; they represent five plus minutes chatting with state and provincial lawmakers to familiarize, educate and understand who we are as a community. AANR dues help fund these efforts which ultimately creates a better identity in the eyes of the law.
